

# RESURFACING & ROUNDABOUT

S.R. 11 (Perkins Highway) from the Volusia County Line to U.S. 1

**Flagler County**

## PROJECT DESCRIPTION

The Florida Department of Transportation (FDOT) is implementing roadway improvements along State Road (S.R.) 11 (Perkins Highway) in Flagler County. These enhancements include the construction of a roundabout at the intersection of S.R. 11 and County Road (C.R.) 304 to improve safety and traffic flow. S.R. 11 will also be resurfaced from the Volusia County Line to U.S. 1 in Bunnell.

Additional safety measures include three new mid-block crosswalks equipped with Rectangular Rapid Flashing Beacons (RRFBs) and the construction of a shared-use trail along the east side of S.R. 11 between Old Haw Creek Road and Bay Street.

Work also includes drainage and lighting upgrades, new roadway signage, pavement markings, and small alignment shifts to encourage safer driving speeds.

## WHAT TO EXPECT

At various times during construction, motorists can expect lane closures, changing traffic patterns, and short-term road closures with detours, as necessary. Temporary pavement will be used to shift traffic while the roundabout is being constructed. Electronic message boards, road work signage, and flagging operations will be used to direct traffic around closures. The contractor will maintain access to businesses and residences during construction. Pedestrian detours will be utilized as necessary. Motorists and pedestrians are asked to exercise caution while traveling through the work zone.

Uneven pavement is a common, unavoidable roadway condition with resurfacing projects as the contractor must place different layers of asphalt during various phases of construction. Road conditions during construction are short-term and will become less apparent as the project nears completion.

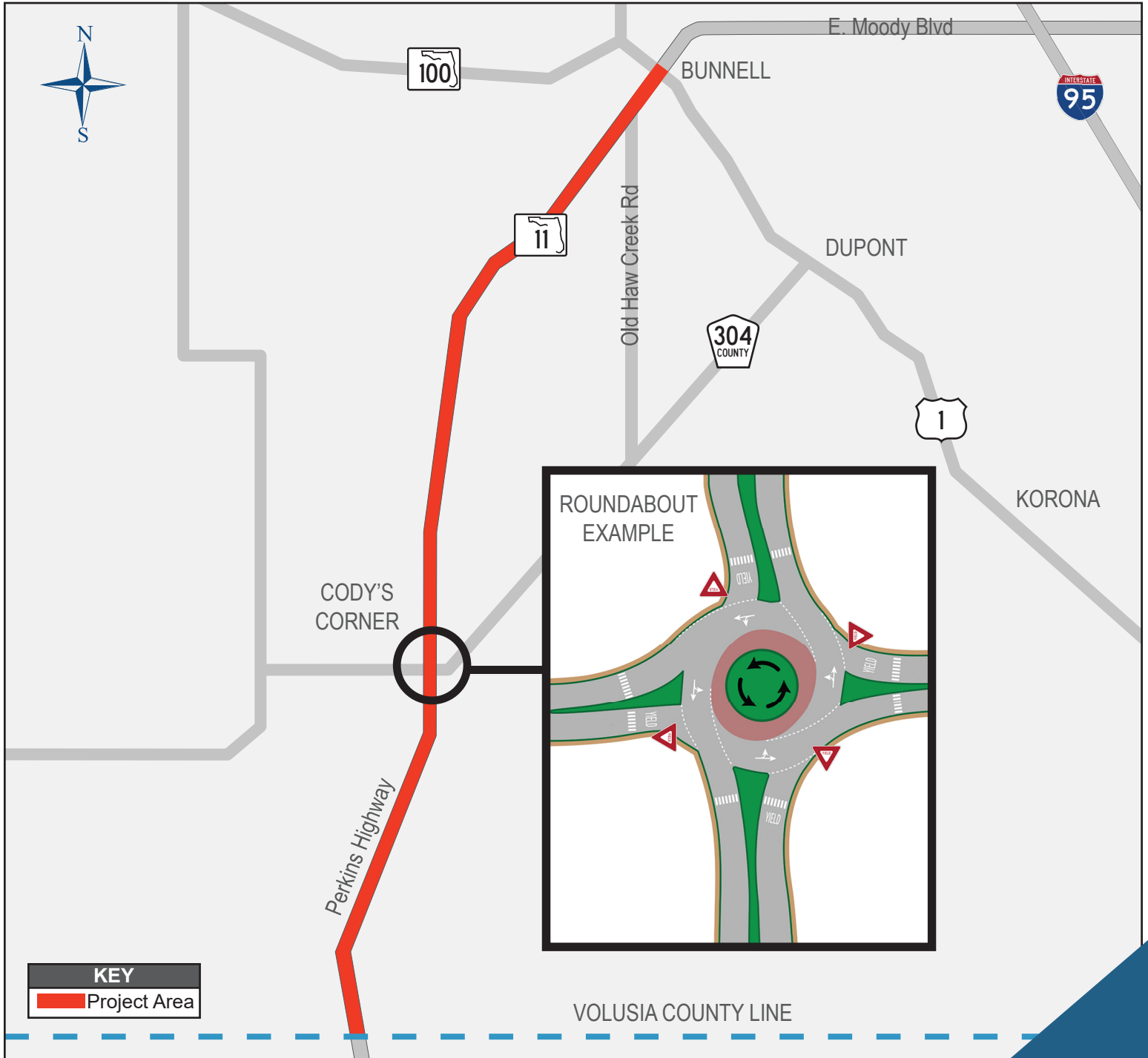
