

# RESURFACING AND SAFETY IMPROVEMENTS

5th Avenue (S.R. 500/U.S. 192) from Riverside Place to Miramar Avenue (S.R.A1A)

## Brevard County

### PROJECT DESCRIPTION

The Florida Department of Transportation (FDOT) will be improving safety and traffic operations on 5th Avenue (State Road (S.R.) 500/U.S. 192) in the town of Indialantic. FDOT aims to improve safety throughout the roadway by repaving the segment of 5th Avenue (S.R. 500/U.S. 192) from Riverside Place to Miramar Avenue (S.R. A1A) to enhance pedestrian safety along the corridor. The project proposes to upgrade mid-block crossings, add raised crosswalks and add pedestrian-activated lights known as Rectangular Rapid Flashing Beacons (RRFBs) to enhance the visibility of the crosswalks. There are a total of four RRFBs and they will be located east of Riverside Drive, east of Ramona Avenue, in front of Indialantic City Hall, and east of Shannon Avenue. A new Pedestrian Hybrid Beacon (PHB) signal will also be added at Palm Avenue. Other improvements include reducing the speed limit to 30mph as well as reconstructing designated pedestrian curb ramps and driveways to comply with current ADA standards, modifying existing drainage, and upgrading pedestrian lighting.

This project will improve roadway conditions for motorists, introduce speed management methods, help enhance pedestrian visibility in the area, and improve accessibility along 5th Avenue (S.R. 500/U.S. 192).

### WHAT TO EXPECT

The Department has added signage to inform motorists of the speed table ahead. Please expect to see new posted speed limit signs, and roadway markings when approaching the speed table. Motorists should also expect lane closures throughout construction. Electronic message boards and other signage will be used to alert motorists of traffic changes. Uneven pavement is a common, unavoidable roadway condition with projects that require resurfacing, as the contractor must place different layers of asphalt during various phases of construction. Road conditions during construction will become less apparent as the project progresses. Pedestrian detours will be in place in areas where the sidewalk is inaccessible during construction. Motorists and pedestrians are asked to exercise caution and reduce their speed while driving through the work zone.
