

ROAD WIDENING UPDATE

U.S. 27/441 from Lake Ella Road to Avenida Central/Griffin Avenue

Lake County

PROJECT DESCRIPTION

The Florida Department of Transportation (FDOT) is widening U.S. 441 from four to six lanes between Lake Ella Road and Avenida Central (at Griffin Avenue) in Lady Lake. Both northbound and southbound U.S. 441 are being expanded from two to three lanes. Bicycle lanes and sidewalks are being added along the 4.157-mile length of the project. Landscape improvements are underway and construction of one retention pond has been completed along Edwards Road. One of two bridges along U.S. 441 over County Road (C.R.) 25 has already been demolished and the team is preparing for the removal of the second bridge, which will be replaced with a new signalized intersection. The intersection will connect C.R. 25 with U.S. 441 on the east side of the highway. Additional work includes drainage improvements, signing, lighting upgrades and median access changes. Currently, this project is more than two-thirds complete and the estimated completion date is January 2024.

WHAT TO EXPECT

There will be traffic shifts in effect for the area to facilitate the demolition of the U.S. 441 Bridge over C.R. 25 beginning in early 2023. Construction of the roadway section from Griffin View Drive to Lake Ella Road is projected to be complete in summer 2023 and the projected completion date of the roadway section from Griffin View Drive to West Hermosa Street is fall 2023. The new intersection on C.R. 25 is expected to open to traffic in late 2023.

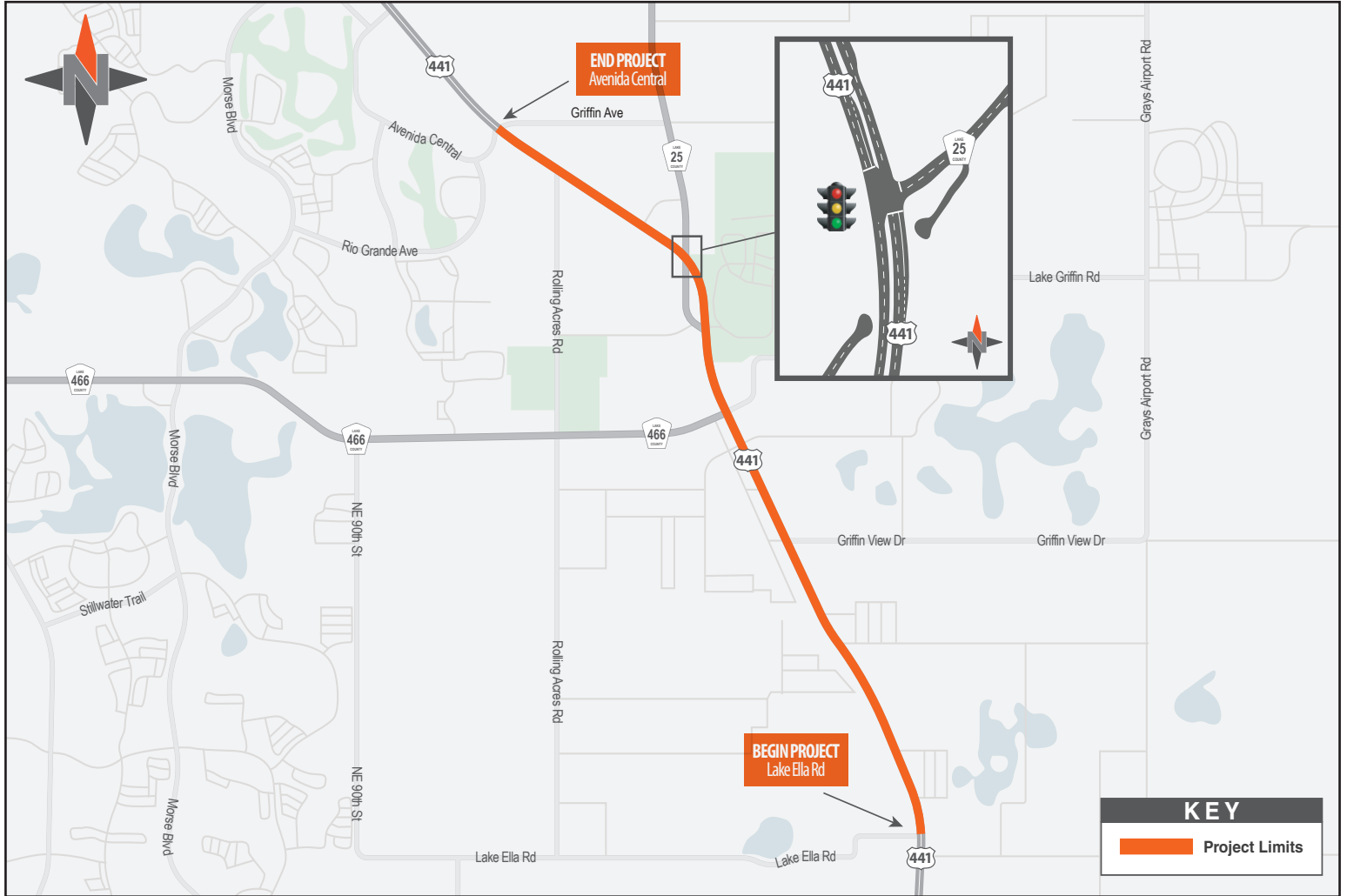
