**Safety improvements are proposed at the intersections of State Road (SR) 426 at Tangerine Avenue and SR 551 at Georgeann Street in Orange County. The projects address crash patterns at these intersections by converting the full median openings to directional median openings. These modifications reduce traffic conflict points at the intersections, improving safety.**

This public hearing is being conducted to give interested persons an opportunity to express their views concerning the location, conceptual design, and social, economic, and environmental effects of the proposed improvements. Draft project documents will be available for public review from February 4, 2016 to March 7, 2016 at the Orange County Library - Chickasaw Branch, 870 North Chickasaw Trail, Orlando, FL 32825.
