



Project Description

In order to improve skid resistance during wet conditions, the department is designing the recommended improvements to this section of Sand Lake Road. Additional features will be incorporated into the design to further enhance safety and usability. Restriping for a bike lane will be added to the south side of State Road (SR) 482 from 150 feet east of Goldensky Lane to Voltaire Drive, and sidewalks will be added at some locations. The pedestrian crossings at select intersections will also be improved and brought up to ADA (Americans with Disabilities Act) compliance.



Project Schedule and Cost

The design is scheduled to be complete in Spring 2016 and construction is expected to start in Fall 2016. Construction cost estimate is \$1.8 million.

Adjacent / Nearby Projects

Orange County's Adaptive Signalization Project is currently under construction and is located within this project's corridor. The signalization project will interconnect the signals at the Voltaire Drive, Winegard Road and Lake Gloria Boulevard intersections and adjust their timing based upon current traffic conditions, thereby increasing the efficiency of traffic flow.
