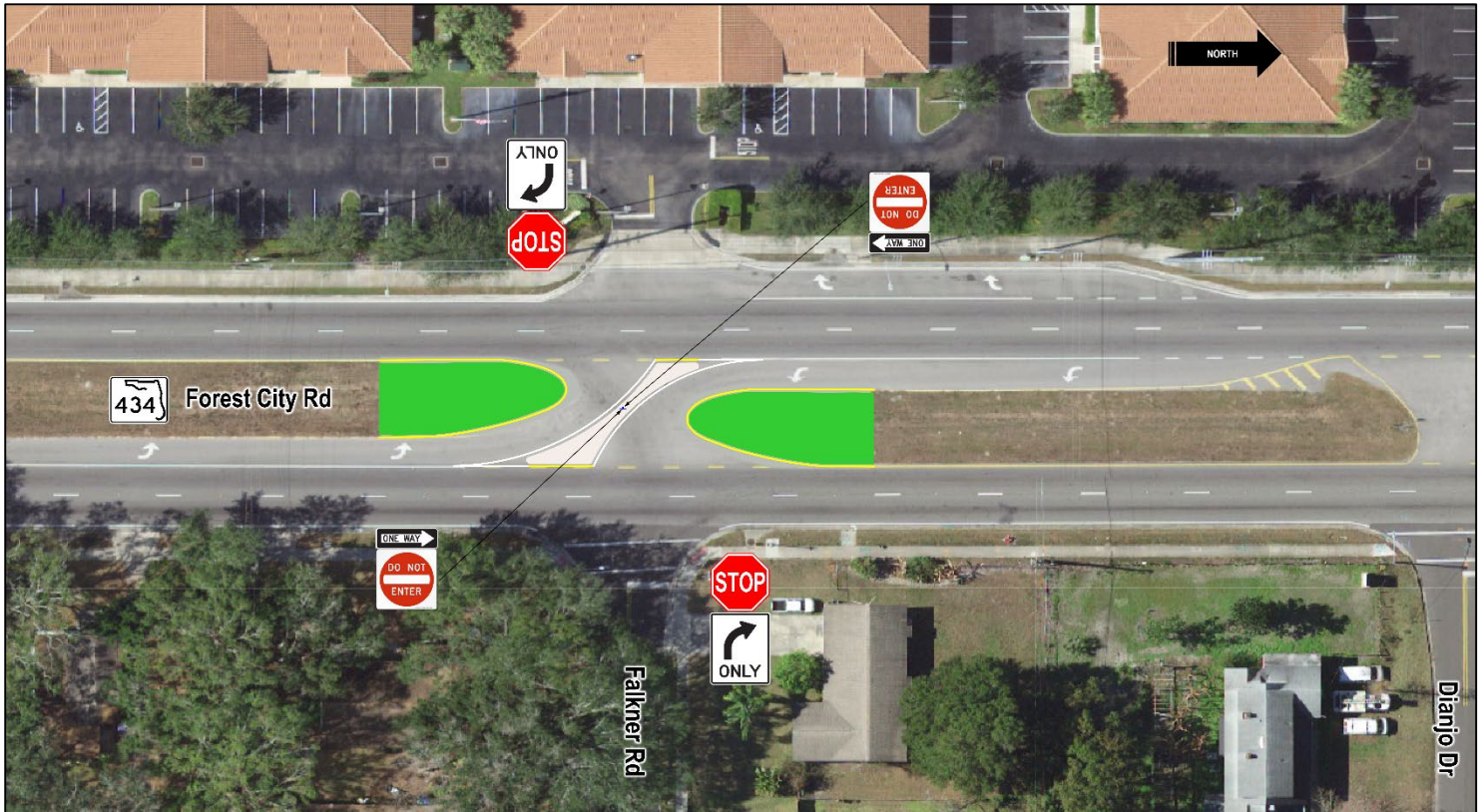


**JOIN US FOR A PUBLIC HEARING ON TUESDAY, FEBRUARY 12, 2019**

**PROPOSED IMPROVEMENTS**



The Florida Department of Transportation (FDOT) is proposing to improve safety and traffic operations on Forest City Road at the intersection with Falkner Road. Proposed improvements consist of converting the full median opening to a bi-directional opening that allows southbound traffic on Forest City Road to make a left turn onto Falkner Road and northbound traffic to make a left into the medical office complex driveway; however, traffic from Falkner Road and the office complex will only be able to turn right onto Forest City Road. This reduces the number of conflict points at the intersections, improving safety.

A court reporter will be present to record proceedings, and assist with comments, as part of the project record. Written comments can be submitted at the hearing, sent by mail to Dave Mixon, Florida Department of Transportation, 719 S.
