



State Road (S.R.) A1A Construction

Flagler County

Financial Project ID Nos.: 440557-5, 440557-6, 440557-7

The Florida Department of Transportation will be constructing improvements along three segments of S.R. A1A in Flagler County that were damaged by Hurricane Matthew. The segments have been designed as separate projects, but construction of all three segments is being completed under one contract.

The largest section is Segment 2 (440557-6), which stretches from South 22nd Street to South 9th Street. Specific information about that segment is detailed below. Information about Segment 1 and Segment 3 is included on the back of this flyer.

Segment 2 (440557-6): S.R. A1A from South 22nd Street to South 9th Street


Work on this nearly 1.5-mile segment will consist of reconstructing S.R. A1A to include one lane of travel in each direction separated by a landscaped median. A system of French drains and other drainage improvements will be constructed to control water runoff and reduce undermining of the roadway. No parking will be permitted along the east side of S.R. A1A in this section to accommodate increased vegetation of the dune, and the speed limit in this section will be reduced to 30 mph. The sidewalk along the west side of the roadway will be reconstructed.

Traffic Flow During Construction

Southbound S.R. A1A traffic can expect a continuous road closure and detour for much of the construction. Motorists should use Central Avenue from South 7th Street to South 23rd Street. Northbound S.R. A1A traffic will stay on S.R. A1A. A designated pedestrian walkway will be maintained. Pedestrians are asked to use caution and obey signs directing them through the work area.

Beach Access

Construction on this segment will impact some existing beach walkovers. The contractor is responsible for repairing or reconstructing impacted walkovers to match pre-construction condition as soon as construction activities allow for safe beach access.





Segment 1 (440557-5): S.R. A1A from South 25th Street to South 23rd Street

On this segment of the roadway, the work focuses on fortifying the dune with additional sand and vegetation. An erosion control mat also will be installed on this section. During construction, motorists can expect single lane closures with flagging operations.



Segment 3 (440557-7): S.R. A1A from North 18th Street to Osprey Drive



The northern most segment will include the construction of a seawall to protect the roadway. The wall will be buried by additional sand and dune plantings. An erosion control mat will also be installed to aid in sand and dune stabilization. A shallow swale will be constructed between the roadway and dune to help control water runoff. The project also will include milling and resurfacing of the roadway. Parking will be prohibited on the east side of the roadway to protect the dunes.

Traffic Flow During Construction

Single lane closures with flagging operations will be needed during construction. Work is expected to occur during daylight hours. Pedestrian walkways will be provided, and access to driveways will be maintained.

Beach Access

Construction on this segment will impact some existing beach walkovers. The contractor is responsible for repairing or reconstructing impacted walkovers to match pre-construction condition as soon as construction activities allow for safe beach access.
