



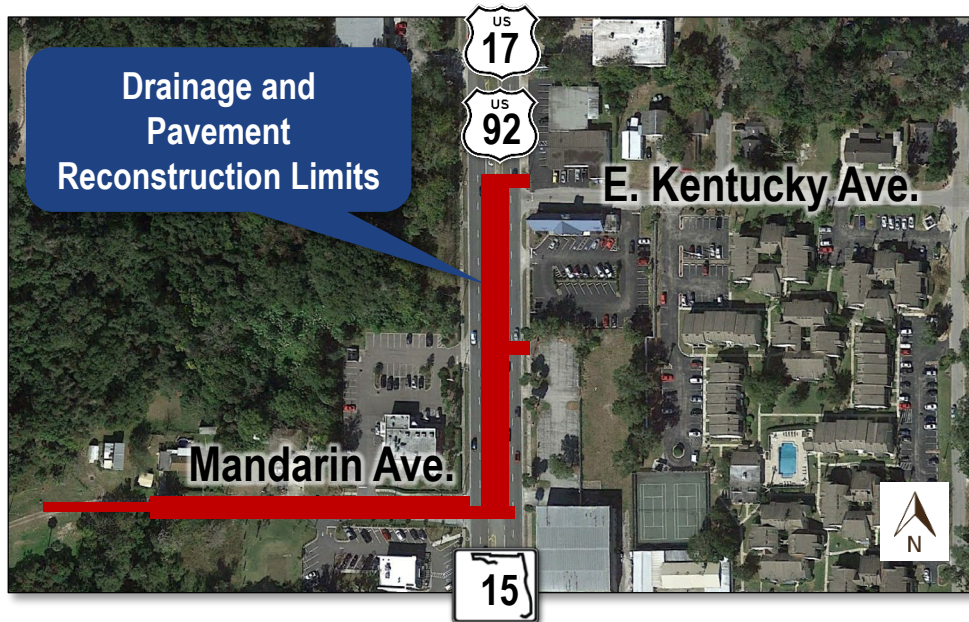

PROPOSED IMPROVEMENTS



The Florida Department of Transportation (FDOT) is proposing drainage improvements on North Woodland Boulevard from Mandarin Avenue to north of East Kentucky Avenue. Proposed improvements consist of adding drainage inlets, adding underground drainage pipes along the median of North Woodland Boulevard and Mandarin Avenue, relocating utilities, and repaving North Woodland Boulevard and Mandarin Avenue within the project limits.

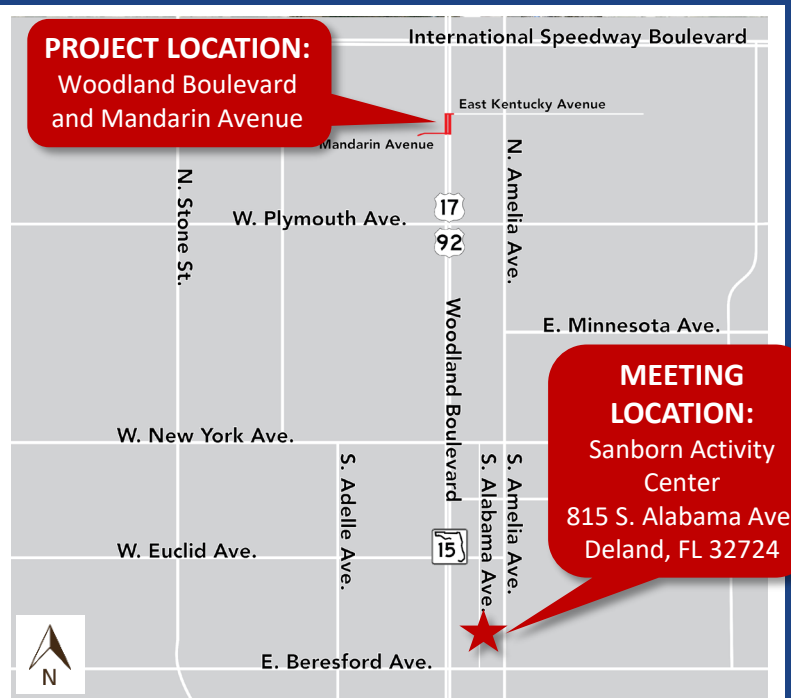
