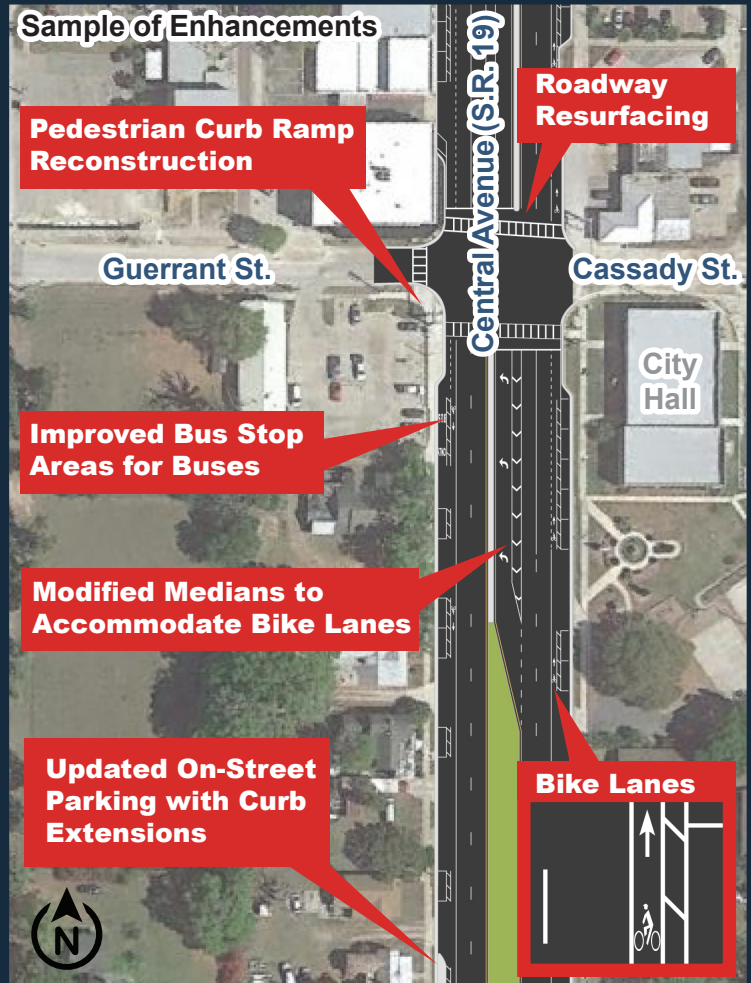

Resurfacing and Roadway Improvements

The Florida Department of Transportation (FDOT) is proposing resurfacing on Central Avenue (State Road (S.R.) 19) from Golden Gem Drive to south of Palmetto Street in the City of Umatilla in Lake County. Proposed improvements include resurfacing all travel lanes, shoulders, and on-street parking areas. Also included in the project are narrowing the median between travel lanes to accommodate a four-foot-wide bicycle lane, sidewalk reconstruction, and related drainage, signage and pavement marking improvements.

The meeting is being conducted as a Virtual Public Meeting (VPM), which is a free live presentation or webinar over the internet, on Thursday, September 17, 2020, beginning at 5:30 p.m. Persons who wish to participate in the virtual meeting will need to register in advance by going to: <https://fdot.cc/sr19>.

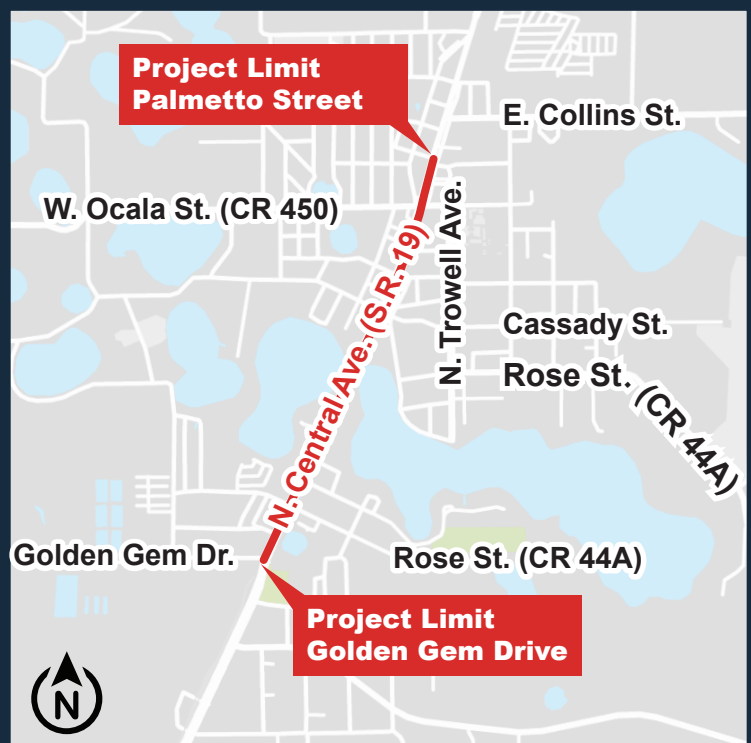

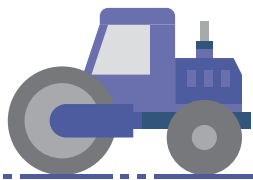




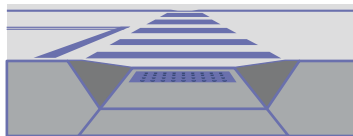
