

# SHARED-USE NONMOTORIZED TRAIL

Palmetto Avenue from Ridge Boulevard to Beville Road

**Volusia County**

## PROJECT DESCRIPTION

The Florida Department of Transportation (FDOT) is constructing a 12-foot-wide concrete shared-use trail that will travel 1.3 miles along the east side of South Palmetto Avenue from Ridge Boulevard to Beville Road in the cities of South Daytona and Daytona Beach in Volusia County. The trail will be separated from the roadway by a grass buffer. This project will also include minor drainage improvements.

This project is part of FDOT's Shared-Use Nonmotorized (SUN) Trail network, which prioritizes cyclist and pedestrian safety by developing and constructing paved trail corridors that are physically separated from vehicle traffic. Once completed, the multi-use path will connect to the existing Daytona Beach trail north of the project limits as a segment of the St. Johns River-to-Sea Loop. The St. Johns River-to-Sea Loop (SJR2C) is a 260-mile paved multi-use trail project underway in northeast and central Florida. It runs through five counties and is part of the East Coast Greenway, a 3,000-mile walking and biking route which connects 15 states from Maine to Florida.

## WHAT TO EXPECT

The existing sidewalk will be removed and replaced with the shared-use trail in two consecutive phases, with the northern end of the trail constructed first, and the southern end constructed second. Work will take place during daytime hours.

In the first phase, motorists traveling northbound on South Palmetto Avenue will be diverted to nearby South Ridgewood Avenue (U.S. 1) between Beville Road and Big Tree Road. In the second phase, motorists traveling northbound on South Palmetto Avenue will be diverted to South Ridgewood Avenue (U.S. 1) between Ridge Boulevard and Big Tree Road. Southbound vehicle traffic will remain on South Palmetto Avenue during both phases.

During construction, pedestrian and bicycle traffic will be maintained on the roadway pavement, separated from southbound vehicle traffic by a temporary barrier. Openings in the temporary barrier will provide driveway access throughout construction. All features of this trail will be contained within publicly owned and maintained land, also known as Right of Way, along South Palmetto Avenue.

Electronic message boards and other signage will be in place to help direct drivers through the work zone. The schedule may change due to weather or other unforeseen circumstances.
