

# ROADWAY IMPROVEMENTS

State Road (S.R.) 60 Widening & U.S. 441 Resurfacing

## PROJECT DESCRIPTION

The Florida Department of Transportation (FDOT) is resurfacing and widening S.R. 60 to accommodate a new 12-foot-wide center turn lane from west of U.S. 441 to east of Florida's Turnpike in Yeehaw Junction. Additionally, FDOT is resurfacing all travel lanes on U.S. 441 from the Osceola/Okeechobee County line to S.R. 60.

The new center turn lane will help to alleviate congestion from vehicles and large trucks turning into the Pilot gas station and improve operations between the U.S. 441 intersection and Florida's Turnpike on and off ramps. Additional improvements on S.R. 60 include new 5-foot-wide paved outside shoulders, drainage upgrades, a new traffic signal on S.R. 60 at the Florida's Turnpike ramps, and new highway lighting. Work on U.S. 441 also includes making minor safety and drainage upgrades and installing new signs and pavement markings.

## WHAT TO EXPECT

Motorists should expect daytime and/or nighttime single lane closures at any time on U.S. 441 and single lane closures between 8 p.m. and 8 a.m. on S.R. 60. Electronic message boards and other signage will be used to direct traffic through the work zone.

Uneven pavement is a common roadway condition with resurfacing projects as the contractor must put down different layers of asphalt during various phases of construction. Motorists are asked to use extra caution while driving through the work zone. Road conditions during construction are short-term and will become less apparent as the project progresses.

Additionally, the level of work activity will vary during different phases of construction, and paving operations will be intermittent.
