

### **PURPOSE**

The purpose of this flyer is to share information and let you know that the Florida Department of Transportation (FDOT) is conducting roadway improvements in your area. As shown on the project location map below, the project is located on the South Orange Avenue (State Road (S.R.) 527) from Sand Lake Road/McCoy Road (S.R. 482) to Prince Street (where Orange Avenue splits into one-way pairs) in Orange County.



### **PROJECT OVERVIEW**

The purpose of this project is to mill and resurface Orange Avenue (State Road (S.R.) 527) from Sand Lake Road/McCoy Road (S.R. 482) to Prince Street (where Orange Avenue splits into one-way pairs). This project will also include crosswalk realignments, reconstruction of concrete island at Sand Lake Road (S.R. 482), various improvements that comply with current Americans with Disabilities Act (ADA) requirements, connecting sidewalks to remove gaps, drainage improvements, and upgrades to pedestrian signals, signs, and pavement markings. The project length is a little more than 1 mile and located south of downtown Orlando, in the unincorporated Pine Castle Community.

## WHAT TO EXPECT

#### Improvements include:

- Milling and resurfacing the roadway;
- Minor drainage improvements including curb inlet reconstruction;
- Safety improvements including Americans with Disabilities Act upgrades to pedestrian facilities;
- Placement of new signs and pavement markings; and,
- Improving crosswalks and pedestrian signals at Sand Lake Road, Office Court, Glen Rose Road/Nela Avenue, and Landcaster Road intersections.

Nighttime lane closures are anticipated for paving operations, with at least one travel lane being maintained at all times during construction. Access to residential and business driveways will also be maintained by the contractor.

Electronic message boards and advance signage will be provided to alert motorists to upcoming construction activities and to safely direct motorists.

Sidewalks will also be closed periodically. Posted signage as well as a marked pedestrian route will safely direct pedestrians around work.

All work will be performed inside the FDOT right of way.

Once complete, this project will extend the life of the roadway, enhance safety, and provide a smoother riding surface.
