The Florida Department of Transportation (FDOT) is holding a public hearing regarding plans to widen the intersection



along SR 405 (Columbia Blvd.) at Sisson Road in Titusville, Florida. The public hearing is being held to review the latest design plans. The project is funded for construction at the end of 2019. This project will involve right-of-way acquisition along the east side of Sisson Road. The proposed widening will also require the construction of a traffic separator along Sisson Road for approximately 200 feet. The limits of this project are from the beginning of the eastbound left turn lane to approximately 200 feet east of the intersection on SR 405 (Columbia Blvd.) as well as Sisson Road to 1,100 feet north of the intersection.

The public hearing is being held Thursday, November 17, 2016, at the Holiday Inn Titusville – Kennedy Space Center – Indian River Room A, 4715 Helen Hauser Blvd, Titusville, FL 32780. The public hearing begins as an open house starting at 5:30 p.m., where the participants may review project documents and discuss the project with staff. There is a brief presentation at 6:00 p.m., after which participants may provide comments.

The FDOT project may consist of temporary lane closures. Access to businesses and residences will be maintained during the construction process. FDOT personnel and consultants will be available at the meeting to discuss the improvements under consideration and answer any questions you may have.

We encourage you to attend this meeting to gain valuable project information. Public participation is solicited without regard to race, color, national origin, age, sex, religion, disability or family status.
