

Existing Conditions

- 4-lane rural typical section with a grass median
- A sidewalk is currently being constructed along the northbound lanes of US 1, from north of Volco Road to Orange Avenue
- A sidewalk is currently being constructed along the southbound lanes of US 1, from north of Indian River Boulevard to Orange Avenue

- To create a safer US 1 corridor by extending the life of existing pavement by milling and resurfacing and by making related improvements
- To prepare a set of construction documents that will be used to complete the project
