State Road 50 (W. Myers Boulevard) Drainage Improvements Design Project from North Bay Lake Avenue to Fiske Avenue

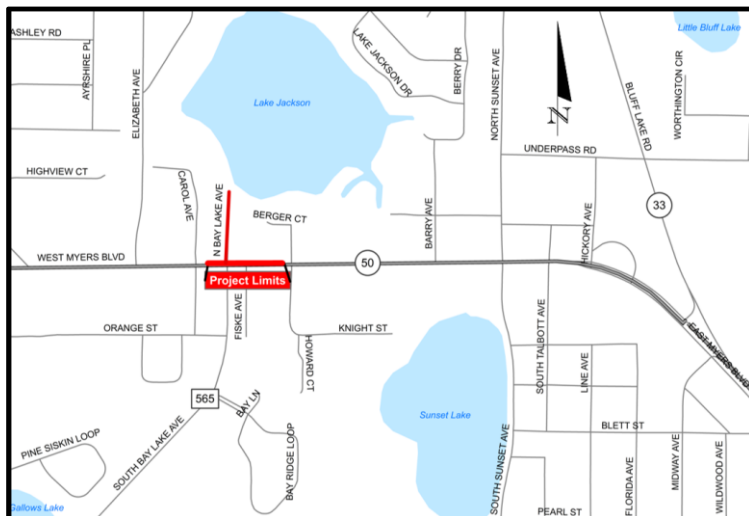
Welcome to the Public Meeting

The Florida Department of Transportation (FDOT) is holding a public meeting to present information about the drainage improvements design project for State Road (SR) 50 (W. Myers Boulevard), from North Bay Lake Avenue to Fiske Avenue in Mascotte, Florida. The meeting is being held on **Tuesday, August 18, 2015 at the Mascotte Civic Center, 121 N. Sunset Avenue, Mascotte, Florida.**

The purpose of this meeting is to present information and to receive public input regarding the proposed improvements. The meeting will be an open house format **from 5:30 p.m. to 7:30 p.m.** Project information will be available for review along with a project presentation that will be running on a continuous loop. SR 50 Drainage Improvements Design Project from North Bay Lake Avenue to Fiske Avenue

Project Overview

This project is located in Mascotte, Florida within Lake County. The project limits are from North Bay Lake Avenue to Fiske Avenue. The existing retention pond was designed and constructed in 1992 surrounded by walls on all four sides. Currently, the pond does not recover and overtops during rain events. Also, SR 50 is a hurricane evacuation route.

The design phase for this project is anticipated to be completed by Spring 2016. The drainage improvements include modifying the existing control structure and enlarging downstream pipes to improve the pond's performance capabilities. These improvements will take place within existing right-of-way so no additional right-of-way is needed. Construction for this project is funded in Fiscal Year 2019.
