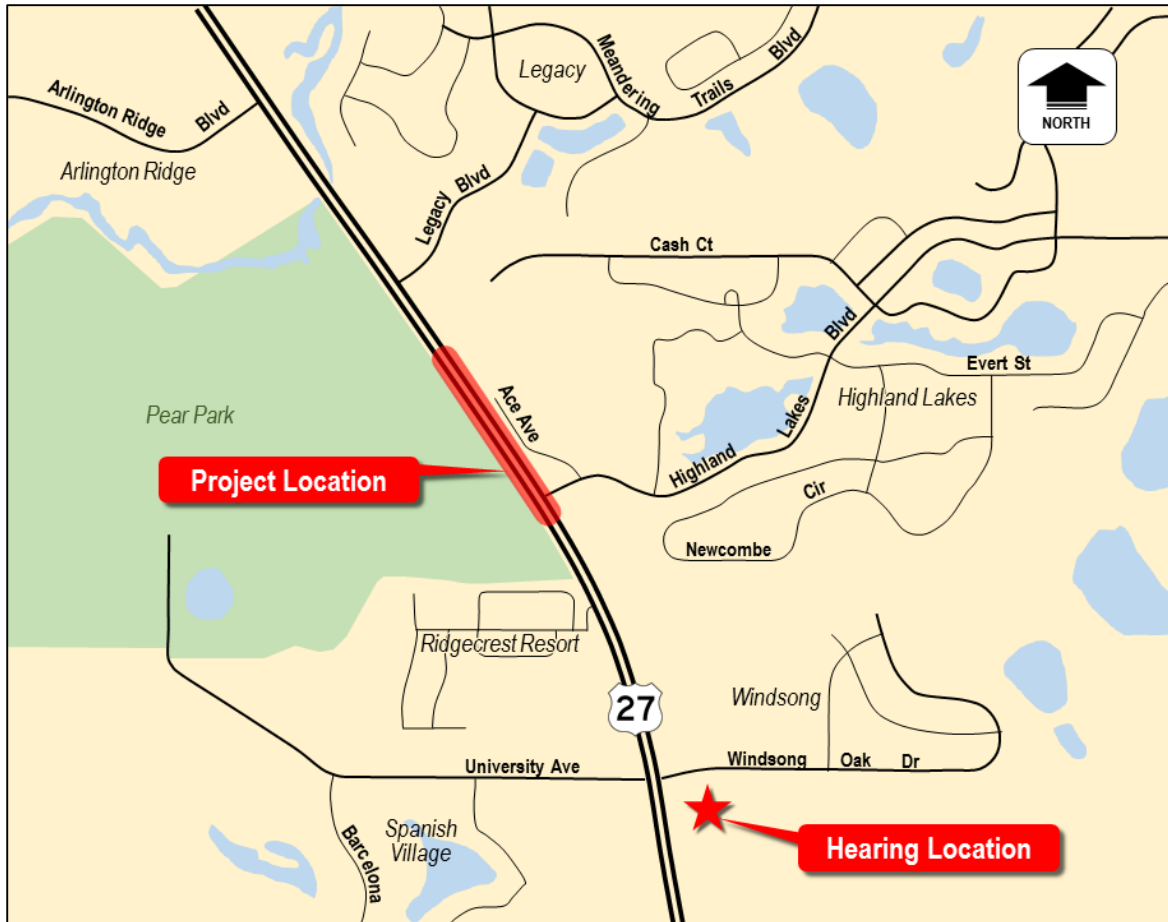




# NOTICE OF PUBLIC HEARING

The Florida Department of Transportation will conduct a Public Hearing for the proposed safety improvements on S.R. 25/U.S. 27 at the intersection of Highland Lakes Boulevard. The project addresses operational and safety concerns in the area by converting the full median opening to a southbound directional median opening. Also proposed, is the addition of a designated northbound directional median opening for U-Turns to the north of this intersection. These modifications reduce traffic conflict points at the intersection, improving safety.

This public hearing is being conducted to give interested persons an opportunity to express their views concerning the location, conceptual design, and social, economic, and environmental effects of the proposed improvements. Draft project documents will be available for public review from October 5, 2017 to November 6, 2017 at the Leesburg Public Library, 100 East Main Street, Leesburg, FL 34748, Monday-Thursday 9:00 a.m. to 8:00 p.m., Saturday 9:00 a.m. to 5:00 p.m. Participants may provide verbal comments directly to a court reporter before and after the formal presentation.
