Silver Star Road (S.R. 416) at Hansrob Road Median Modifications, Orange County

The Florida Department of Transportation (FDOT) will hold a public hearing regarding project plans on Silver Star Road (S.R. 416) from John Young Parkway (S.R. 423) to east of Hansrob Road on Tuesday, June 15 at 5:30 p.m. The purpose of this project is to increase safety, improve traffic flow, and reduce the number of areas where vehicles cross paths by installing a median using vertical posts. This project is an interim solution until the future construction of a concrete median. The intersection at Hansrob Road will continue to allow right turns in all directions, as well as westbound left turns into the WaWa driveway. Northbound and southbound left turns and through movements, as well as eastbound left turns, will be prohibited at this intersection. FDOT is offering multiple ways to participate in the same live hearing.
