

# Fiske Boulevard (S.R. 519) Intersection Improvements At Levitt Parkway/Lakemoor Boulevard

**Brevard County**

### **Project Description**

The Florida Department of Transportation (FDOT) is proposing improvements at the intersection of Fiske Boulevard (State Road (S.R.) 519) and Levitt Parkway/Lakemoor Boulevard in Rockledge. Proposed improvements include constructing new traffic signals at the intersection to enhance safety for all users. They will be mounted on mast arms and will provide separate phases for left turns from northbound and southbound Fiske Boulevard.

Additionally, pedestrian enhancements are planned, which include installing new eastbound/westbound crosswalks across

Fiske Boulevard and pedestrian crossing signals for all four crosswalks.

Short sidewalk connections will be constructed along Lakemoor Boulevard. Pedestrian ramps will also be constructed for new crosswalks on Fiske Boulevard to meet current American with Disabilities Act (ADA) standards.

This project is based on recommendations from a 2021 intersection safety and traffic signal warrant analysis for Fiske Boulevard (S.R. 519).

# Fiske Boulevard (S.R. 519) Safety Improvements

From Barbara Jenkins Street to King Street (S.R. 520)



### **Project Description**

The Florida Department of Transportation (FDOT) is proposing safety improvements on Fiske Boulevard (State Road (S.R.) 519) from Barbara Jenkins Street to King Street (S.R. 520) in Cocoa. Proposed improvements include reducing the speed limit to 35 mph within the project limits, extending the northbound right lane beyond Stone Street, constructing a shared use path to accommodate bicycles, and adding a concrete traffic separator between the northbound and southbound lanes.

The project also proposes installing a midblock pedestrian crossing just north of Barbara Jenkins Street. This midblock crossing will include a raised concrete median/pedestrian refuge with overhead Rectangular Rapid Flashing Beacons (RRFBs).



The RRFBs will increase driver awareness and visibility at the midblock crossings. When activated by a pedestrian wanting to cross the roadway, the signals will flash yellow lights to alert drivers. By state law, drivers are required to stop at any marked crosswalk when a pedestrian is present.
