

Project Description

The Florida Department of Transportation (FDOT) is planning resurfacing along Orange Blossom Trail (U.S. 441) from north of Old Dixie Highway to Mary Louis Lane (Orange County line). The purpose of this project is to maintain the roadway and enhance safety along the corridor.

Proposed improvements include:

- Resurfacing all travel lanes and shoulders to extend the life of the roadway.
- Pedestrian/Multimodal Improvements -
 - Constructing new sidewalk between signalized intersections and side streets, filling in gaps where possible, to improve connectivity.
 - Replacing pedestrian curb ramps as needed to meet current Americans with Disabilities Act (ADA) standards.
 - Enhancing bus loading and unloading areas by adding new sidewalk connections to improve accessibility.
 - Constructing a new bus loading and unloading zone at the Victory Charter School bus stop.
- Intersection Improvements -
 - Adding or improving intersection lighting at Donegan Avenue, Carroll Street, Centerview Boulevard, and Mary Louis Lane.

Orange Blossom Trail (U.S. 441) Intersection Improvements at Donegan Avenue

Project Description

The Florida Department of Transportation (FDOT) is proposing improvements at the intersection of Orange Blossom Trail (U.S. 441) and Donegan Avenue in Osceola County. The goal of this project is to enhance intersection safety and operations for drivers and pedestrians.

Proposed improvements include:

- Traffic Signal & Pedestrian Signal Upgrades -
 - Reconstructing the traffic signal with new mast arms and new signal heads to improve visibility and functionality.
 - Installing "Turning Vehicles Yield to Pedestrians" signs to alert drivers and enhance pedestrian safety.
 - Upgrading pedestrian signals and incorporating Leading Pedestrian Interval (LPI) into signal timing to give pedestrians a head start crossing the street before vehicles are allowed to move.
- Corner Reconstruction -
 - Rebuilding of the northeast and southwest corners with new curbs and sidewalks to meet current Americans with Disabilities Act (ADA) standards.



These proposed improvements will enhance pedestrian safety, improve traffic flow and visibility, and increase mobility for all users.
