

ROADWAY WIDENING

S.R. 426/C.R. 419 from Pine Avenue to Adeline B. Tinsley Way

PROJECT DESCRIPTION

The Florida Department of Transportation (FDOT) is expanding a 1.4-mile section of State Road (S.R.) 426/County Road (C.R.) 419 from Pine Avenue to Adeline B. Tinsley Way. This project will widen the current two-lane roadway to a four-lane divided urban roadway, with safety and accessibility upgrades distributed throughout the corridor. Key improvements include the addition of a 22-foot-wide raised grass median, bike lanes, and sidewalks on both sides, as well as upgrades to stormwater ponds and other flood control infrastructure.

A significant feature of this project is the installation of a pedestrian hybrid beacon (PHB) near Oviedo High School to assist students in safely crossing S.R. 426. When activated, this beacon stops traffic in both directions and has been shown to reduce pedestrian crashes by 55% and serious injury and fatal crashes by 15%. Among the first of its kind in downtown Oviedo, this beacon is part of FDOT's broader commitment to enhancing pedestrian and cyclist safety on state roadways.

WHAT TO EXPECT

Motorists should anticipate areas of uneven pavement within the project limits, a common condition during construction when the contractor applies multiple asphalt layers in phases. In addition, motorists should also expect temporary lane closures at different points of the road, as crews will require buffer zones to protect them from oncoming traffic during construction operations. Many of these roadway conditions are short-term, and will gradually improve as the project progresses.

While workers are on site, motorists are strongly encouraged to exercise caution and reduce their speed to ensure safety for everyone on the roadway. The project timeline is subject to change and may be adjusted depending on weather conditions or unforeseen events. 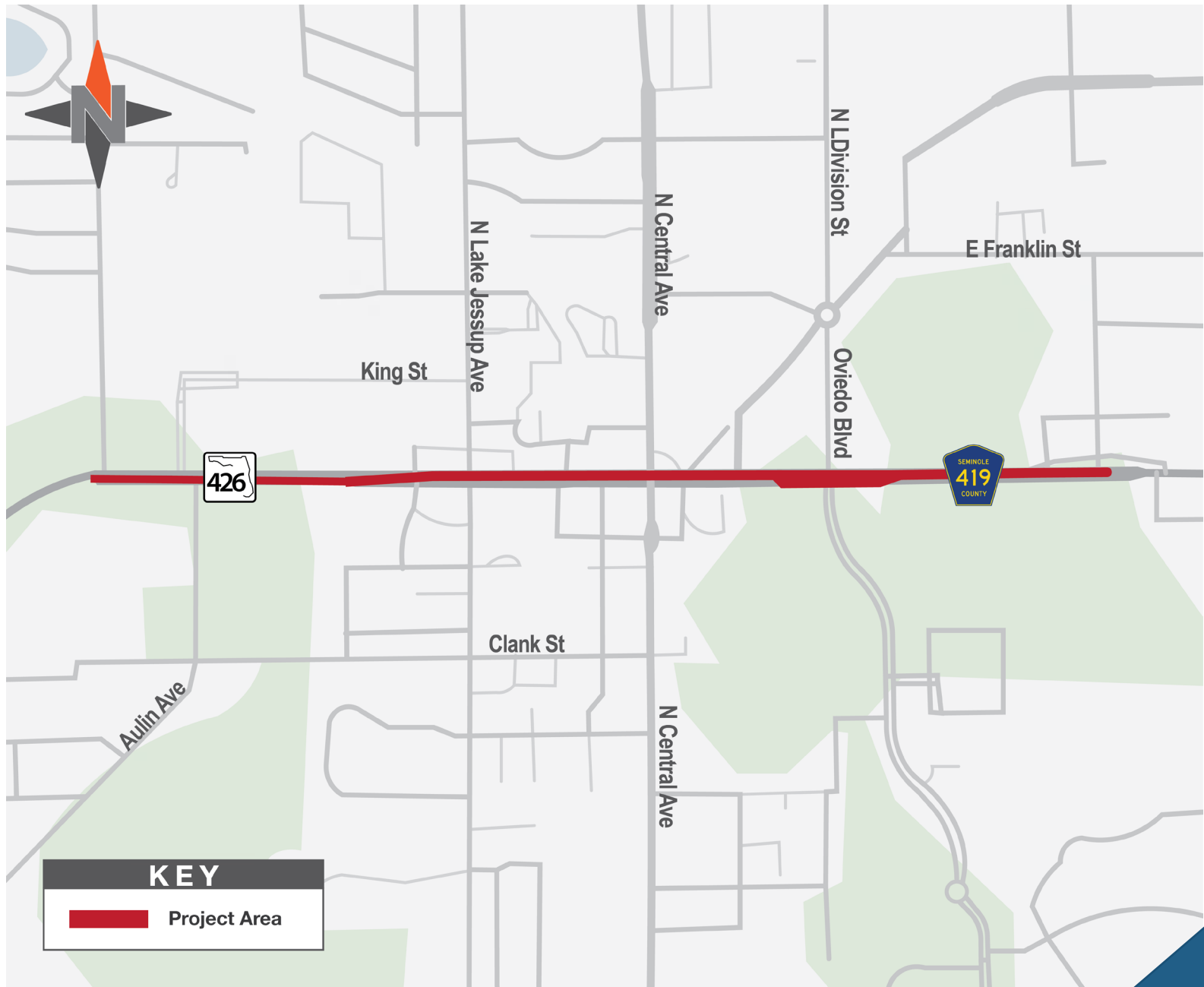
