## PROJECT DESCRIPTION

The Florida Department of Transportation (FDOT) is widening State Road (S.R.) 426/County Road (C.R.) 419 from two lanes to a four-lane roadway. It will consist of two travel lanes in each direction separated by a 22-foot-wide raised grass median. Other improvements include adding bike lanes and sidewalks to both sides. New stormwater ponds will be constructed to improve overall water quality as well as flood control.

## WHAT TO EXPECT

Motorists should expect lane closures between 8 p.m. and 7 a.m. during the week. Electronic message boards and other signage will be used to direct traffic through the work zone.

Uneven pavement is a common roadway condition with resurfacing projects as the contractor must put down different layers of asphalt during various phases of construction. Motorists are asked to use extra caution while driving through the work zone. Road conditions during construction are short-term and will become less apparent as the project progresses.

Please be advised it is the property owner's responsibility to remove or relocate any privately owned irrigation, landscaping, decorations, and/or fencing within FDOT right of way before the start of construction. If there are questions about whether you may have items within the right of way, please contact the Community Outreach Coordinator for FDOT Oviedo Operations at 407-278-2713.

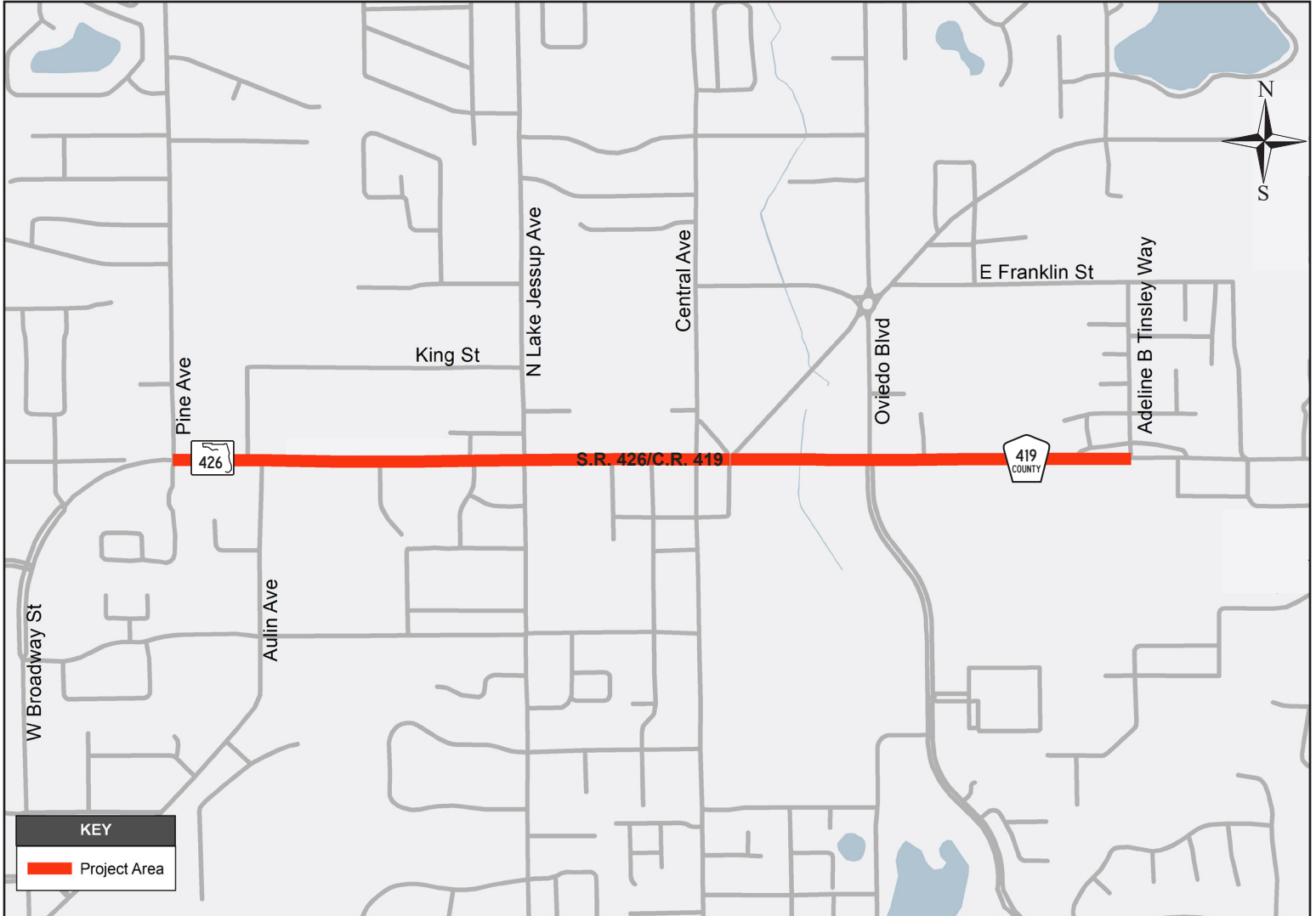
