PROJECT DESCRIPTION

The Florida Department of Transportation (FDOT) is resurfacing U.S. 441/U.S. 17-92 (North Main Street) from north of Cypress Street to Old Dixie Highway in Kissimmee.

Additional improvements include restriping travel lanes in both directions, replacing signage, upgrading curb ramps and other pedestrian features to comply with current Americans with Disabilities Act (ADA) standards, installing pedestrian/bicycle railings at the unnamed canal crossing, and enhancing crosswalks at West Columbia Avenue.

WHAT TO EXPECT

During construction, motorists should expect lane closures between 8:30 p.m. and 6:30 a.m.; however, occasional daytime lane closures could occur. Electronic message boards and other signage will be used to direct traffic through the work zone.

Uneven pavement is a common, unavoidable roadway condition with resurfacing projects as the contractor must put down different layers of asphalt during various phases of construction. Motorists are asked to use extra caution while driving through the work zone. Road conditions during construction are short-term and will become less apparent as the project progresses.

Additionally, the level of work activity will vary during different phases of construction, and paving operations will be intermittent. The contractor will maintain pedestrian access to sidewalks during construction using signed detours, traffic control devices, and/or temporary walkways and ramps, when appropriate.

Please be advised it is the property owner's responsibility to remove or relocate any privately owned irrigation, landscaping, decorations, and/or fencing within FDOT right of way before the start of construction. FDOT reserves the right to cut and cap any irrigation and remove any items that conflict with the planned work in the right of way. 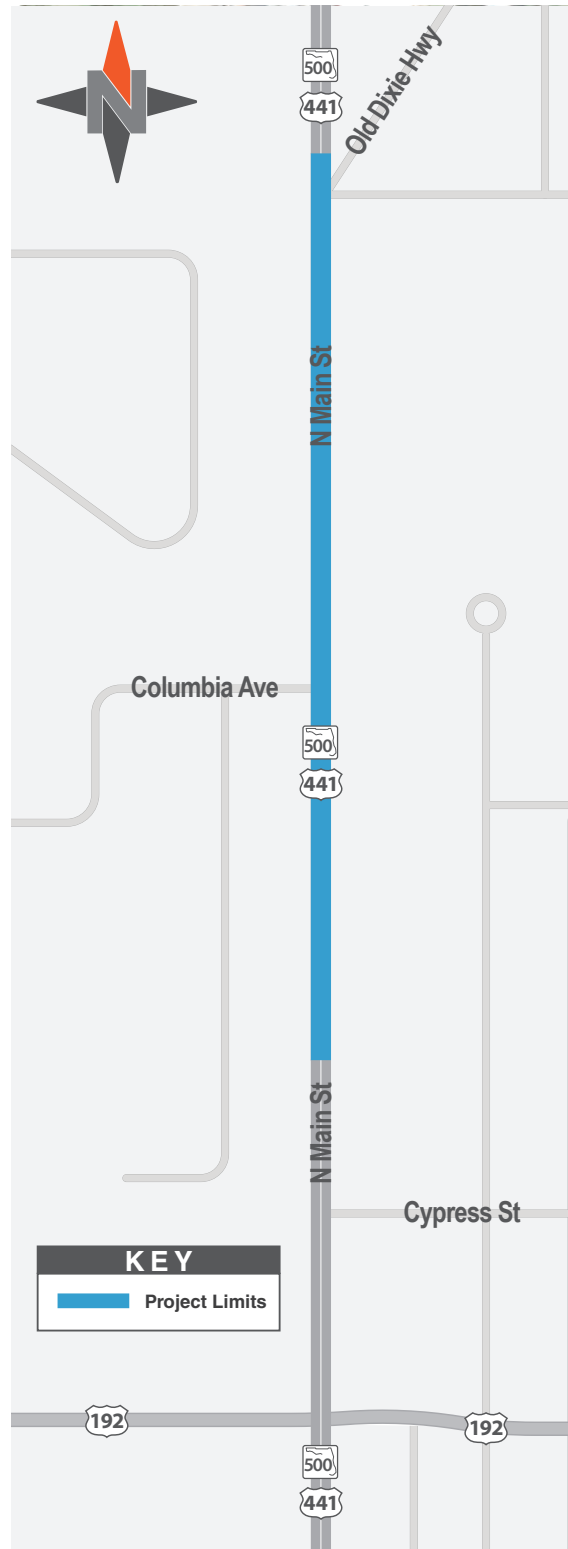
