PROJECT DESCRIPTION

The Florida Department of Transportation (FDOT) will provide pedestrian safety improvements along North Spring Garden Avenue (State Road (S.R.) 15A) and will resurface the roadway from just south of West Plymouth Avenue to just north of West International Speedway Boulevard (County Road (C.R.) 92).

The improvements will include curb and gutter reconstruction, minor drainage improvements, upgrading guardrail approaches, extending traffic separators at the intersections with Shady Oak Lane/Clear Lake Drive and Cardinal Lane/Cascades Park Boulevard, and evaluating and updating existing signs, signals, and pavement markings. In addition, the roadway will be milled and resurfaced, and pedestrian lighting will be added at the signalized intersections to enhance pedestrian safety.

WHAT TO EXPECT

Motorists should expect daytime and nighttime single lane road closures along eastbound and westbound West Plymouth Avenue that will require detours. Electronic message boards and other signage will be used to alert motorists of closures and detours.

Uneven pavement is a common, unavoidable roadway condition with projects that require resurfacing as the contractor must place different layers of asphalt during various phases of construction. Road conditions during construction will become less apparent as the project progresses. Motorists are asked to exercise caution and reduce their speed while driving through the work zone.

The contractor will maintain pedestrian access to sidewalks during construction using signed detours, traffic control devices, and/or temporary walkways and ramps, when appropriate. The construction schedule may change due to weather or other unexpected conditions.
