Roadway and Intersection Improvements

The Florida Department of Transportation (FDOT) would like to inform you of proposed roadway improvements on Spring Garden Avenue (State Road (S.R.) 15A) from approximately 500 feet south of Plymouth Avenue to 200 feet north of International Speedway Boulevard in the City of DeLand. These improvements include roadway resurfacing throughout the project's limits, curb ramp reconstruction at pedestrian crossings, guard rail enhancements, median improvements, and minor drainage modifications.

The project will upgrade the intersection at Spring Garden Avenue and Plymouth Avenue to promote driver and pedestrian safety. Work here includes extending the curbs on the east side to reduce pedestrian crossing distances, as well as shifting the traffic signal box from the northwest corner to the southwest corner to reduce vehicular conflicts. Drainage and sidewalk improvements will also take place at the intersection.

Additionally, the medians will be extended at the Shady Oaks/Clear Lake Drive and Cardinal Lane/Cascades Park Boulevard intersections to prevent excessive vehicle queuing that can limit sight distances for drivers. The design also includes traffic signal upgrades and additional pedestrian lighting at the intersections of West Plymouth Avenue and International Speedway Boulevard.

During construction, most detours will be focused on pedestrian activity. However, detours will be in place overnight through some work phases at the intersection of Spring Garden Avenue and Plymouth Avenue.


