PROJECT DESCRIPTION

This Florida Department of Transportation (FDOT) project extends the westbound left-turn lane at the intersection of West Fairbanks Avenue (State Road (S.R.) 426) and U.S. 17-92 (South Orlando Avenue). Additional improvements to westbound West Fairbanks Avenue include roadway resurfacing, widening, reconstruction of sidewalks, curb ramps and driveways, drainage improvements and modifications of signing and pavement markings.

WHAT TO EXPECT

Motorists should expect single and double lane closures on West Fairbanks Avenue from Ward Avenue to U.S. 17-92. Closures will happen during daytime and nighttime hours. Additionally, the level of work activity will vary during different phases of construction, and paving operations will be intermittent.

The contractor will maintain pedestrian access to sidewalks during construction using signed detours, traffic control devices, and/or temporary walkways and ramps, when appropriate.

Please be advised it is the property owner's responsibility to remove or relocate any privately owned irrigation, landscaping, decorations, and/or fencing within FDOT right of way before the start of construction. FDOT reserves the right to cut and cap any irrigation and remove any items that conflict with the planned work in the right of way. 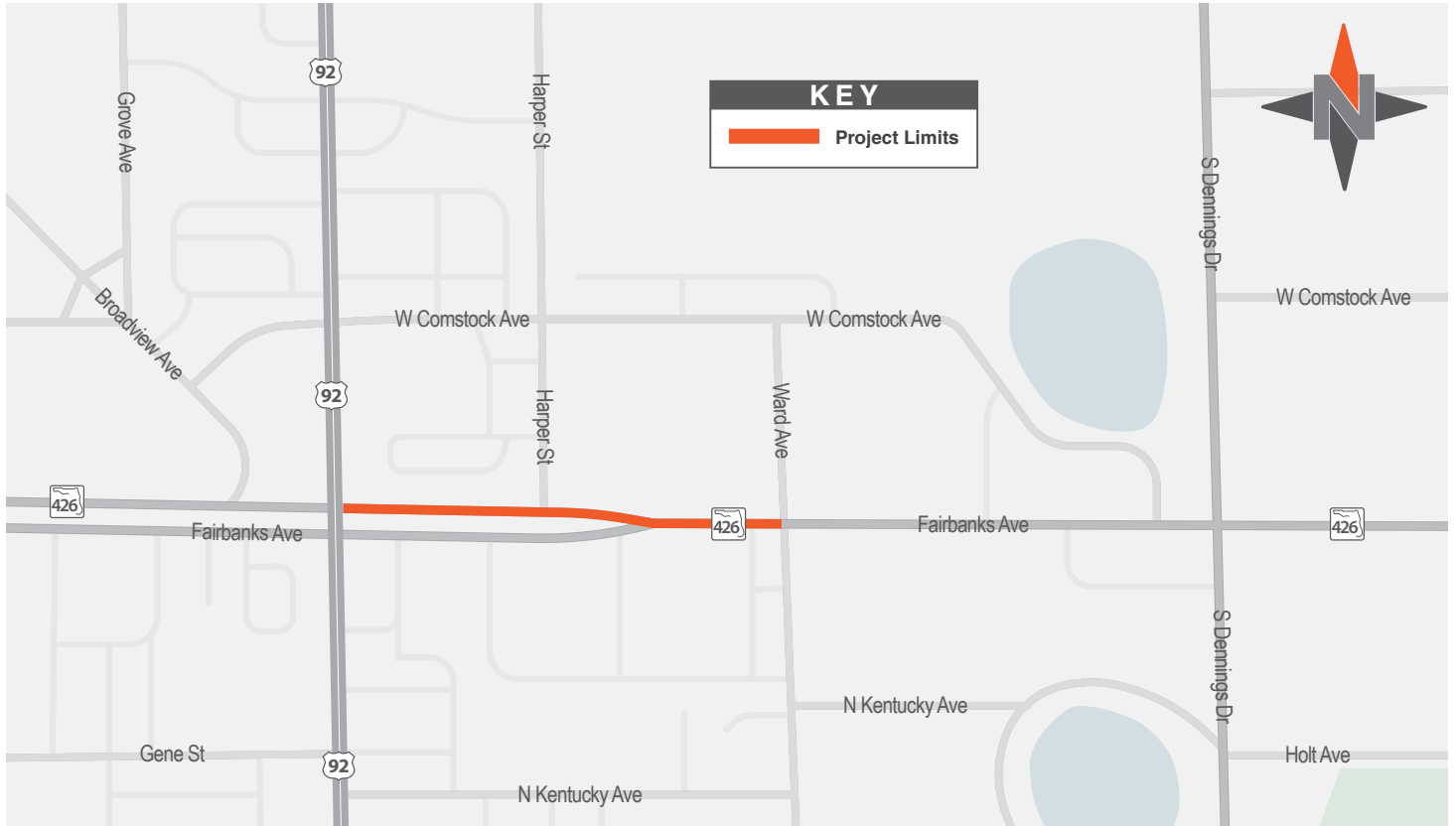
