The Florida Department of Transportation (FDOT) will hold a public meeting regarding project plans on State Road (S.R.) A1A from north of Granada Boulevard (S.R. 40) to Sandra Drive in Ormond Beach on Tuesday, March 28, at 5:30 p.m. The purpose of this project is to repave this section of S.R. A1A and construct improvements to enhance safety and operations along the corridor. FDOT is offering multiple ways to participate in the live meeting.
