U.S. 441 Resurfacing Project, Orange County

The Florida Department of Transportation (FDOT) will hold a public hearing regarding project plans on U.S. 441 from Central Avenue (County Road 437A) to north of Bradshaw Road in Apopka on Tuesday, February 2, at 5:30 p.m. The purpose of this project is to extend the life of the existing roadway by repaving this segment of U.S. 441 and to improve safety along the corridor. The Department is offering multiple ways to participate in the same live hearing.

Virtual: Join from a computer, tablet, or mobile device for free and listen to the live presentation over the internet. The hearing will open at 5:30 p.m., and the presentation will begin promptly at 5:40 p.m. If joining online, please allow adequate log-in time prior to the presentation.
