## PROJECT DESCRIPTION

The Florida Department of Transportation is making improvements to three intersections on Columbia Boulevard in Titusville. Each intersection will be widened to accommodate the construction of additional turn lanes and new bicycle lanes. Other upgrades include resurfacing the roadway and constructing new concrete sidewalk, curbs, and gutters, as well as drainage improvements.

The traffic signals at the intersection will be replaced and upgraded to mast arm poles. In addition, new signing and pavement markings will be placed as part of the upgrades to improve these intersections.

### These lanes will be added at the following intersections:

- Columbia Boulevard/South Street and Cheney Highway  
An eastbound left turn lane will be added on Cheney Highway with an additional northbound receiving lane on South Street.
- Columbia Boulevard and Barna Avenue  
A westbound left turn lane will be added on Barna Avenue.
- Columbia Boulevard and Grissom Parkway  
An eastbound left turn lane will be added on Grissom Parkway.

## WHAT TO EXPECT

During construction, motorists should expect single lane closures between 8 p.m. and 6 a.m. within the project limits.

Electronic message boards and other signage will be used to direct traffic around the closures.

Motorists are asked to use extra caution while driving through the work zone. Road conditions during construction are short-term and will become less apparent as the project progresses. Additionally, the level of work activity will vary during different phases of construction, and paving operations will be intermittent.
