East Silver Springs Boulevard (S.R. 40) Intersection Safety Improvements, Marion County

The Florida Department of Transportation (FDOT) will hold a public meeting regarding project plans on East Silver Springs Boulevard (State Road (S.R.) 40) at NE 14th Street (S.R. 492) on Tuesday, May 25, at 5:30 p.m. The purpose of this project is to improve safety at the intersection by replacing the existing free-flow dual right turn lanes from westbound East Silver Springs Boulevard to westbound NE 14th Street with a single right turn lane under signalized control and adding a 7-foot-wide, buffered bike lane beginning on East Silver Springs Boulevard and connecting to the existing bicycle lane on NE 14th Street. FDOT is offering multiple ways to participate in the meeting. All participants will receive the same information on the proposed project.

Virtual: Join from a computer, tablet, or mobile device for free over the internet.
