Public Information Meeting

The Florida Department of Transportation (FDOT) is finalizing the design plans for the widening of Hoffner Avenue - State Road (SR) 15 from Lee Vista Boulevard to Conway Road. To ensure that you are well informed of the transportation improvements planned for SR 15 and to encourage your input, the FDOT invites you to a Public Information Meeting. This meeting will be held on Thursday, November 20, 2014 from 5:00 pm to 7:00 pm at the El Rey Jesus Orlando Church located at 5235 Hoffner Avenue, Orlando, Florida 32812. (Please see map below).

The meeting will consist of an open house setting during which graphics will be available for viewing. Representatives from both the FDOT and the consultant design team will be in attendance to answer questions. An informal project presentation will be given at 6:00 pm. The project will involve the widening and reconstruction of SR 15 from its current two lane configuration to a four lane divided roadway. The proposed design will include a curb and gutter roadway with two 11-foot travel lanes, one 4-foot undesignated bike lane and a 5-foot sidewalk in each direction separated by a 22-foot grassed median. The project is scheduled to begin construction in the summer of 2015.

The FDOT encourages public participation in the SR 15 project and welcomes comments. Public participation is solicited without regard to race, color, national origin, age, sex, religion, disability or family status. 
