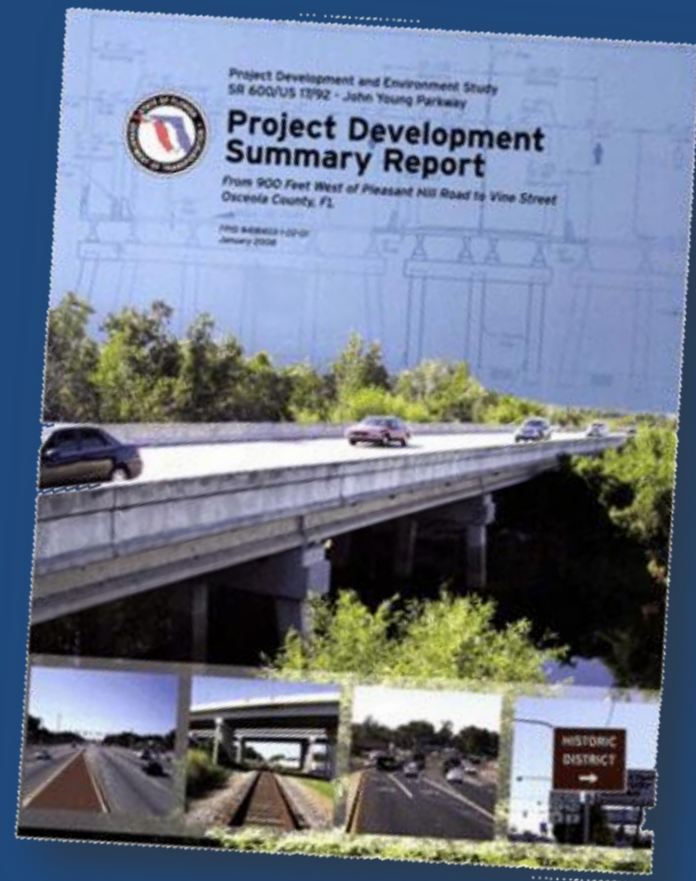

- From South of Portage Street to North of Vine Street



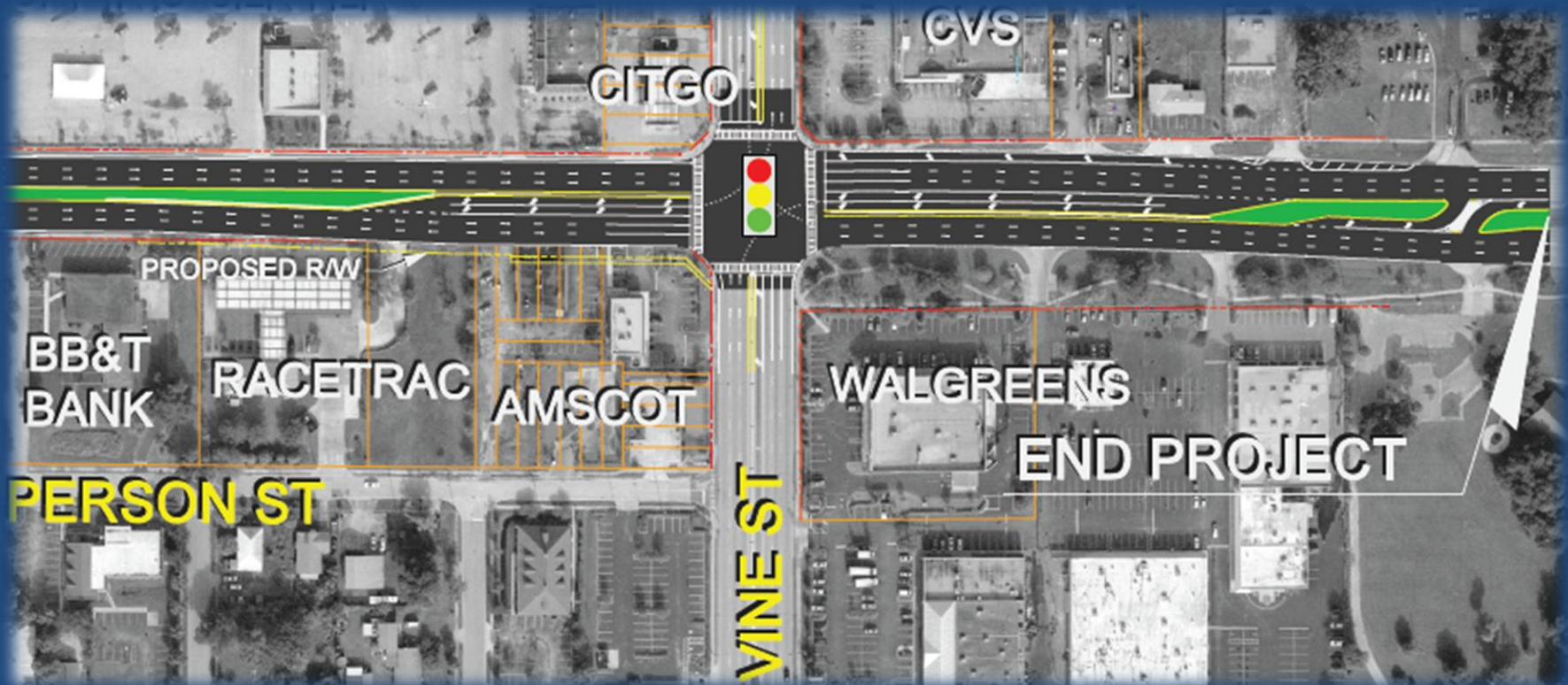

- Widening From 4 Lanes to 6 Lanes

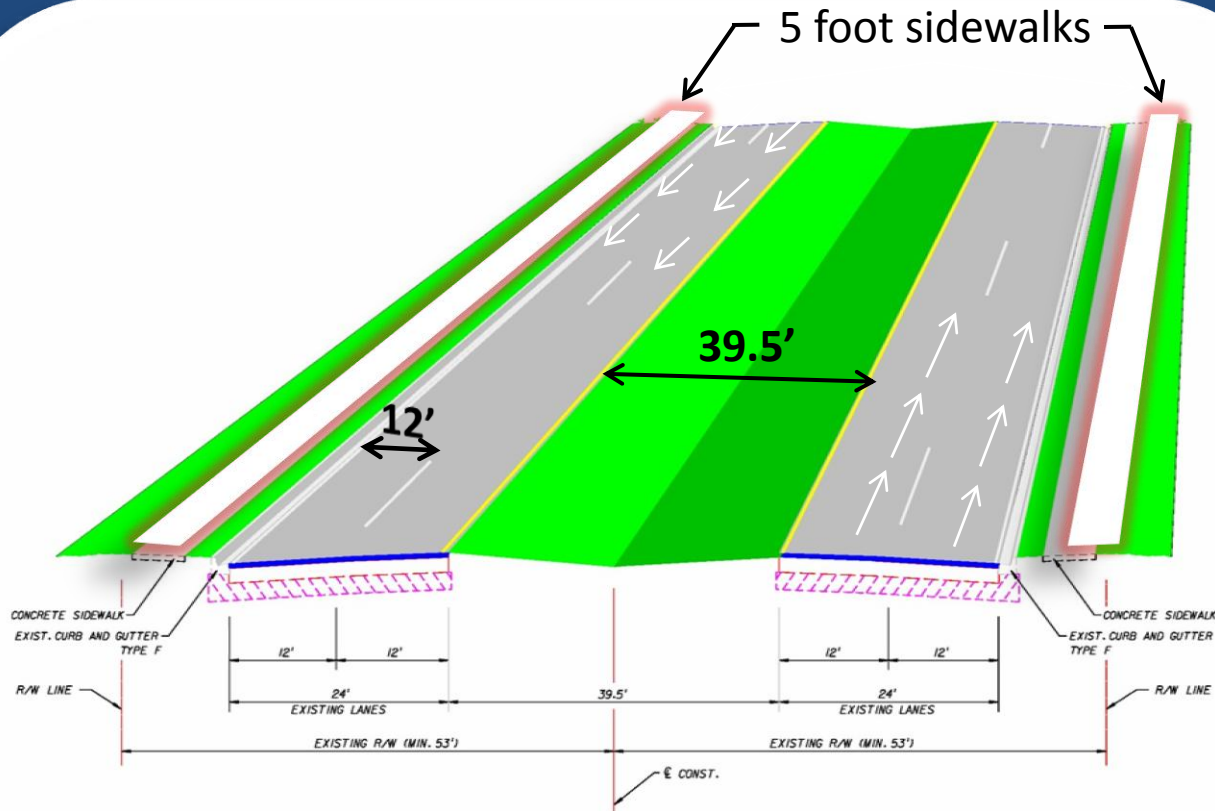

EXISTING CONDITION

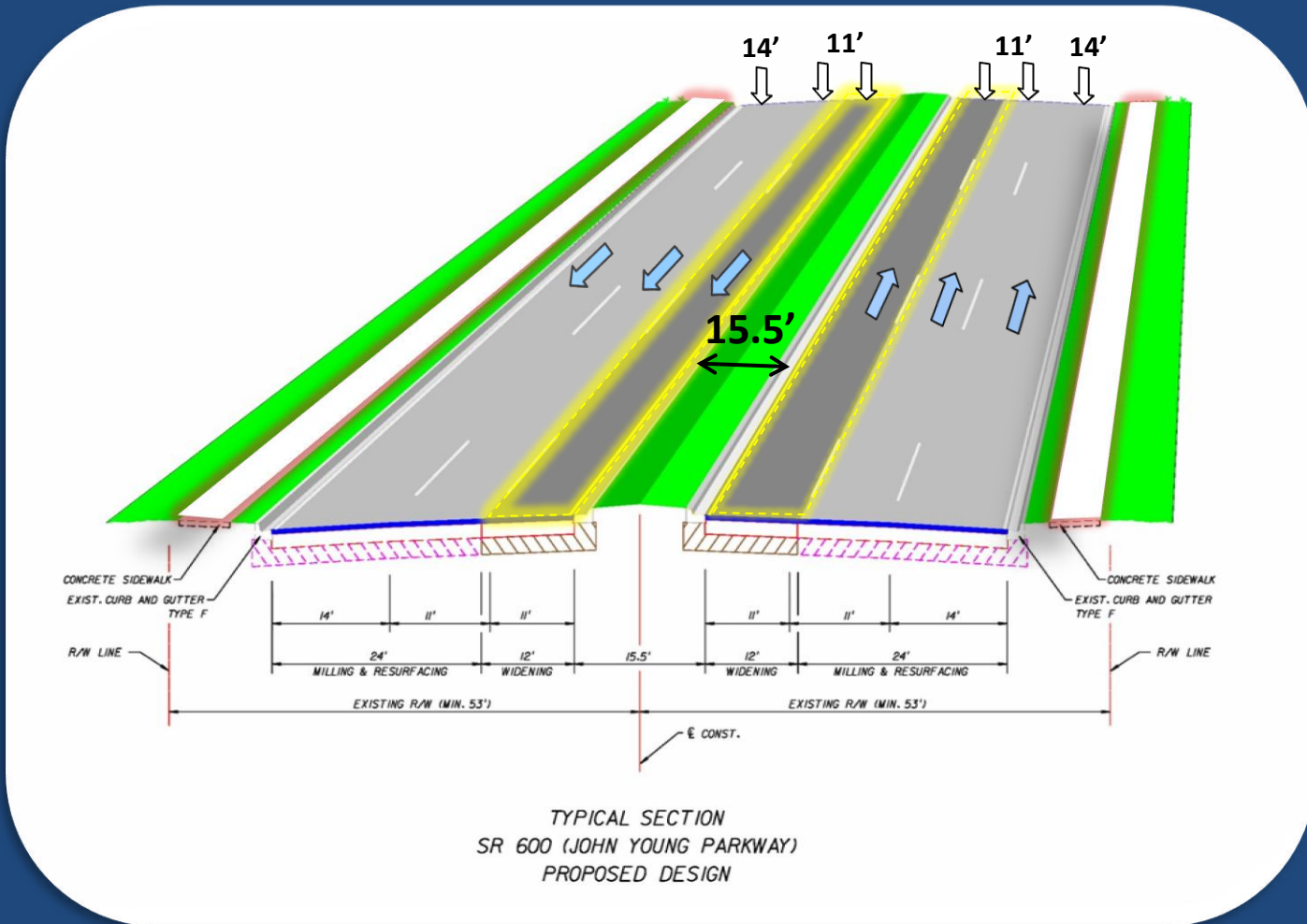


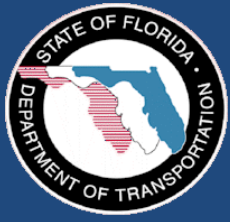

### Proposed Typical Section



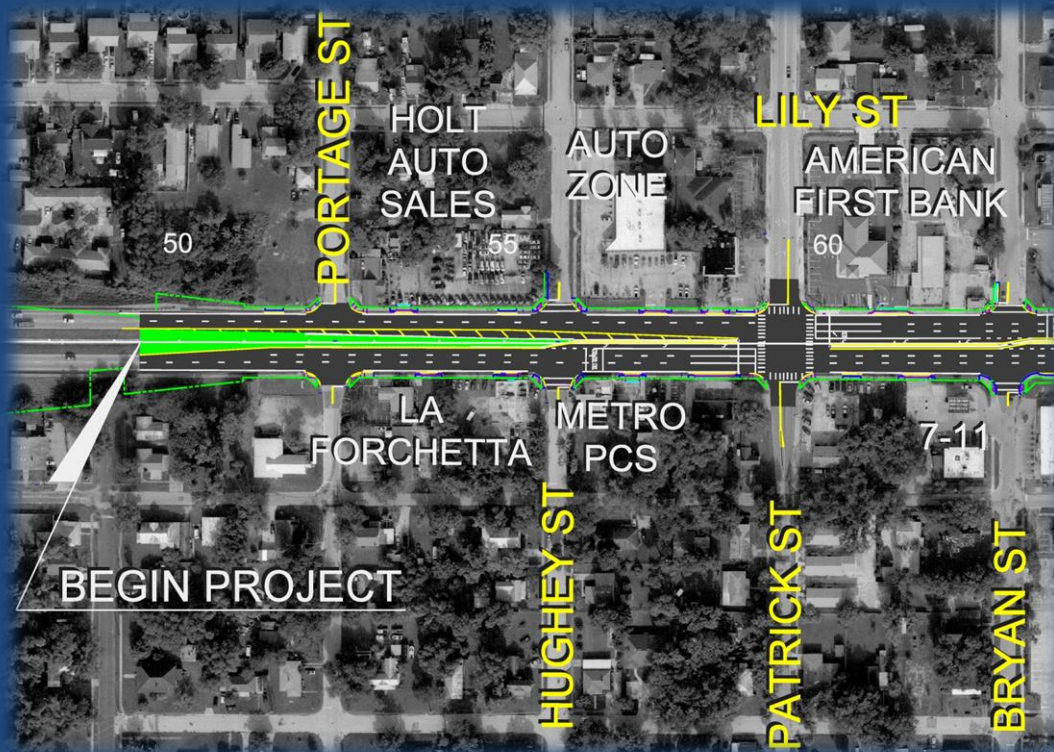

### Access Management

Access Management is the careful planning of the location, design, and operation of driveways, median openings, interchanges, and street connections.



The purpose of access management is to provide access to land development in a manner that preserves the safety and efficiency of the road by reducing conflict points.

- Required at Vine Street, Corners of Intersections, and at Pond Locations



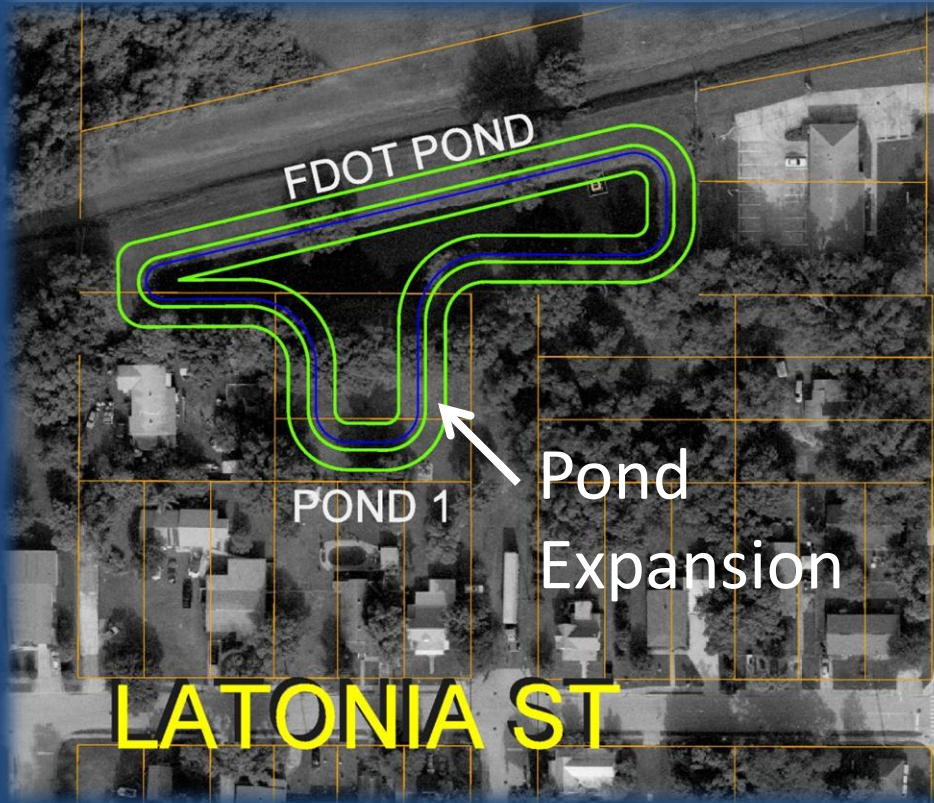

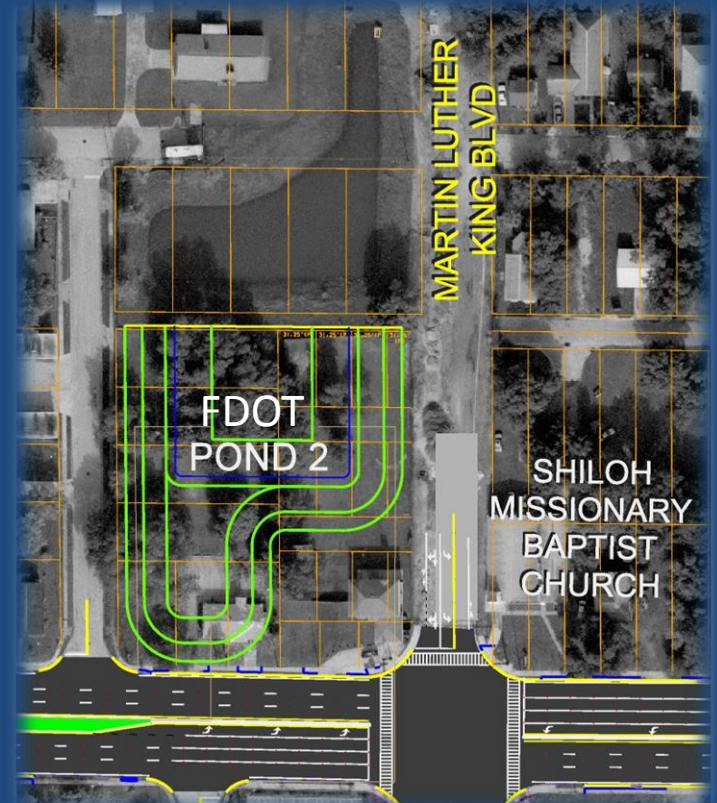

FDOT Pond 2

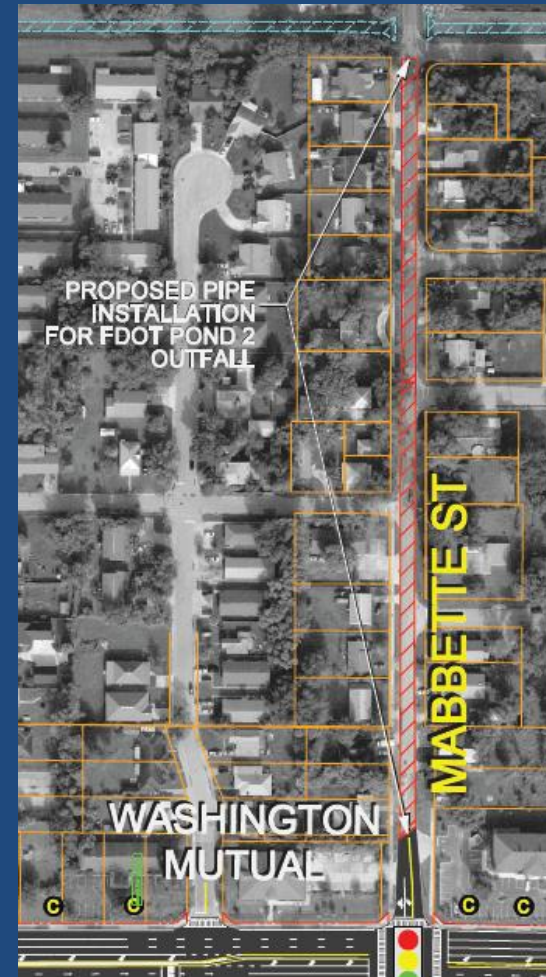

### **Project Schedule**

- Design
  - Cost of \$2.05 Million
  - Completion by Summer 2011
- Right-of-Way
  - Cost Estimation: \$5.3 Million Funded in Fiscal Year 2012
- Construction
  - Cost Estimation: \$5.8 Million in Fiscal Year 2016

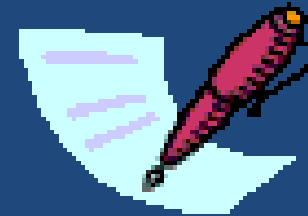

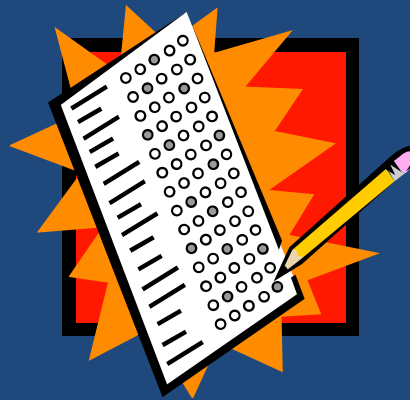
