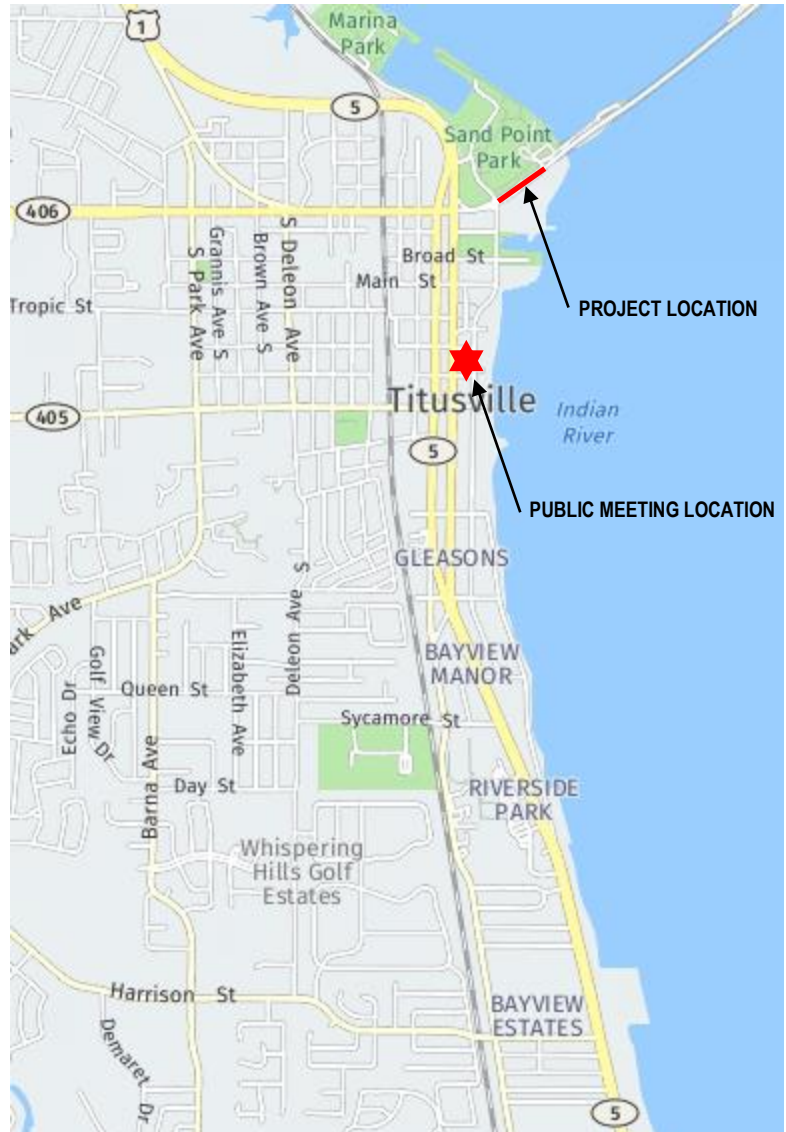
FDOT will hold a public information meeting regarding plans to construct a 10-foot-wide multi-use trail along SR 406, from Indian River Ave. to the Max Brewer Memorial Hwy. Bridge in Brevard County. The meeting is an open house from 5:30-7:30 p.m., during which time displays and other project information will be available for review. Staff will also be available to discuss the project. An informational looping presentation will also be given, playing throughout the open house. The purpose of the meeting is to inform interested persons of the proposed improvements and receive their feedback.

The proposed improvements include a multi-use trail that is part of the existing Coast to Coast Trail and is intended to enhance pedestrian and bicyclist safety in the area, as well as complete the Titusville Gap. Additional roadway modifications and a median will be added on SR 406 to provide a refuge area for pedestrians at the proposed crosswalk.

Public participation is solicited without regard to race, color, national origin, age, sex, religion, disability, or family status.
