### Virtual Public Meeting

The Florida Department of Transportation (FDOT) invites you to a Virtual Public Meeting (VPM) regarding project plans for the Repaving and Pedestrian Improvement project on Orange Blossom Trail (U.S. 17-92/U.S. 441) from Holden Avenue to 34<sup>th</sup> Street on **Wednesday, January 6, 2021, at 6 p.m.**

The purpose of this project is to resurface the roadway and improve pedestrian safety. The proposed design includes constructing three new mid-block crossings with Pedestrian Hybrid Beacons (PHBs) and adding additional improvements to the three existing PHBs. All six PHBs will have raised crosswalks, in-road lighting, and enhanced pavement markings. Other safety improvements include a speed limit reduction to 30 mph, speed feedback signage, median fencing, and pedestrian lighting upgrades. The public meeting is being held to present information and receive community feedback.

**The Department is offering multiple ways for the community to participate in the meeting. All participants, regardless of the platform they choose, will participate in the same live meeting.**

El Departamento de Transporte de Florida (FDOT) le invita a una Reunión Pública Virtual (VPM) sobre los planes del proyecto de Repavimentación y Mejoras de Peatones en Orange Blossom Trail (US 17-92/US 441) desde Holden Avenue hasta 34<sup>th</sup> Street **el miércoles, 6 de enero de 2021, a las 6 p.m.**

El propósito de este proyecto es repavimentar la calzada y mejorar la seguridad de los peatones. El diseño propuesto incluye la construcción de tres nuevos cruces a mitad de cuadra con balizas híbridas para peatones (PHB) y la adición de mejoras adicionales a los tres PHB existentes. Los seis PHB tendrán cruces peatonales elevados, iluminación en la carretera y marcas mejoradas en el pavimento. Otras mejoras de seguridad incluyen una reducción del límite de velocidad a 30 mph, señalización de retroalimentación de velocidad, cercas en la mediana y mejoras en la iluminación para peatones. La reunión pública se lleva a cabo para presentar información y recibir comentarios de la comunidad.

**El Departamento está ofreciendo múltiples formas a la comunidad para que participen en la reunión. Todos los participantes, independientemente de la plataforma que elijan, participarán en la misma reunión en vivo.**



**Push Button to Cross**

Pedestrians must not cross. To activate the PHB, pedestrians must push the button and wait for the "WALK" signal.



**Proceed with Caution**  
Proceda con Precaución

The signal face remains "dark" until pedestrians activate the beacon. Motorists may proceed with traffic.



**Wait!**

Motorists have been alerted that pedestrians want to cross.



**Be Alert**

The beacon begins to flash yellow to warn motorists that it has been activated by a pedestrian waiting to cross the street and they will soon be required to stop.

Traffic will stop momentarily.




**Stop if You Can**  
¡Deténgase si puede!

The brief flashing yellow is followed by a steady yellow to direct motorists that they must stop if they can safely do so, because the signal is about to turn red.



**Start Crossing**  
Comience a Cruzar  
Komanse Travése

While motorists are seeing the steady red, the "WALK" signal is lit for pedestrians, allowing them to begin crossing the roadway. Pedestrians should look in both directions to ensure that all vehicles are stopped.



**Come to a Complete Stop!**


The steady yellow is followed by a steady red signal requiring motorists to come to a complete stop at the stop line.

Pedestrians are in the crosswalk.



**Finish Crossing**  
Termine de Cruzar  
Fini Travése

The pedestrian signal changes to a flashing DONT WALK symbol and countdown timer to notify pedestrians how much time they have to finish crossing. Do not begin crossing during this countdown.



**Stay Stopped Until Clear!**  
¡Permanece detenido hasta que el camino esté despejado!  
Rete kanpe Jiska Klè!

The flashing red light indicates to motorists that they must remain stopped while pedestrians are in the crosswalk but may proceed with caution once pedestrians are clear. Each vehicle in the queue must stop upon reaching the stop bar until the phase ends.
