## State Road (S.R.) 33 Safety Improvements, Lake County

The Florida Department of Transportation (FDOT) will hold a public hearing regarding project plans on State Road (S.R.) 33 from south of Edgewood Boys Ranch Road to S.R. 50 on Thursday, June 17, at 5:45 p.m. The purpose of this project is to enhance safety and traffic operations along S.R. 33 from south of Edgewood Boys Ranch Road to S.R. 50. Improvements include widening paved shoulders through the curves near Edgewood Boys Ranch Road and Groveland Airport Road, reconstructing and upgrading the traffic signals at S.R. 50, and adding a southbound left turn lane at the Pine Island Road (County Road 565B) intersection, and changing the two-way left turn lane from Wright Street to S.R. 50 to a southbound only left turn lane. FDOT is offering multiple ways to participate in the same live hearing.
