## West New Haven Avenue (U.S. 192) Improvements, Brevard County

The Florida Department of Transportation (FDOT) will hold a public meeting regarding project plans on West New Haven Avenue (U.S. 192) from Interstate 95 (I-95) to Babcock Street (State Road (S.R.) 507) on Tuesday, August 16, at 5:30 p.m. The purpose of this project is to resurface West New Haven Avenue to extend the service life of the existing roadway, including necessary roadside improvements.
