S.R. A1A Drainage and Safety Improvements, Brevard County

The Florida Department of Transportation (FDOT) will hold a public meeting regarding project plans on State Road (S.R.) A1A between north of Crescent Beach Drive to south of Minutemen Causeway (FPID No.: 445867-1) and a drainage improvement project along S.R. A1A (FPID No.: 448636-1) on Tuesday, March 1, 2022, at 5:30 p.m. The purpose of these projects is to enhance pedestrian safety along S.R. A1A from Crescent Beach Drive to Minutemen Causeway by adding new pedestrian mid-block crossings and to address drainage concerns. FDOT is offering multiple ways to participate in the live meeting.
