### **Clyde Morris Boulevard (S.R. 483) Improvements, Volusia County**

The Florida Department of Transportation (FDOT) will hold a public meeting regarding project plans on Clyde Morris Boulevard (State Road (S.R.) 483) from Beville Road (S.R. 400) to north of Dunn Avenue in Daytona Beach on Tuesday, March 29, at 5:30 p.m. The purpose of this project is to reconstruct this segment of Clyde Morris Boulevard to improve safety for drivers, pedestrians, and bicyclists. FDOT is offering multiple ways to participate in the live meeting.
