S.R. A1A Resurfacing, Brevard County

The Florida Department of Transportation (FDOT) will hold a public meeting regarding project plans on State Road (S.R.) A1A from north of Pineda Causeway (S.R. 404) to south of Sherry Lee Lane (36th Street) on Thursday, March 10, 2022, at 5:30 p.m. The purpose of this project is to repave this section of S.R. A1A and improve safety by constructing a grassed median from north of Pineda Causeway to south of School Avenue. FDOT is offering multiple ways to participate in the live meeting.
