The Florida Department of Transportation (FDOT) invites you to a public meeting on Wednesday, November 10 from 5:30 p.m. to 7:00 p.m.

PURPOSE

This community event is part of a study that is being conducted to evaluate proposed transportation solutions for segments of Atlantic Avenue (S.R. A1A), East International Speedway Boulevard (U.S. 92), Main Street, Seabreeze Boulevard (S.R. 430), and Oakridge Boulevard (S.R. 430). The study is considering capacity, safety, and multi-modal enhancements along the subject corridors, while minimizing potential impacts to the natural and human environments. Revised corridor concepts developed based on community input received at the first community event will be presented to seek additional input and build consensus.

WAYS TO PARTICIPATE

In-Person Open House Option


