## PURPOSE

This community event is part of a current study that is being conducted to evaluate proposed transportation solutions for a segment of Atlantic Avenue (State Road (S.R.) A1A), from Seabreeze Boulevard (S.R. 430) To Milsap Road. The study is considering capacity, safety, and multi-modal enhancements along the subject corridor while minimizing potential impacts to the natural and human environments. Potential corridor improvement alternatives and innovative treatments will be presented at this event to seek community input in the project development process.

Participants may join the meeting in listen-only mode by dialing 1-866-901-6455 and entering the passcode 180-815-852 when prompted.

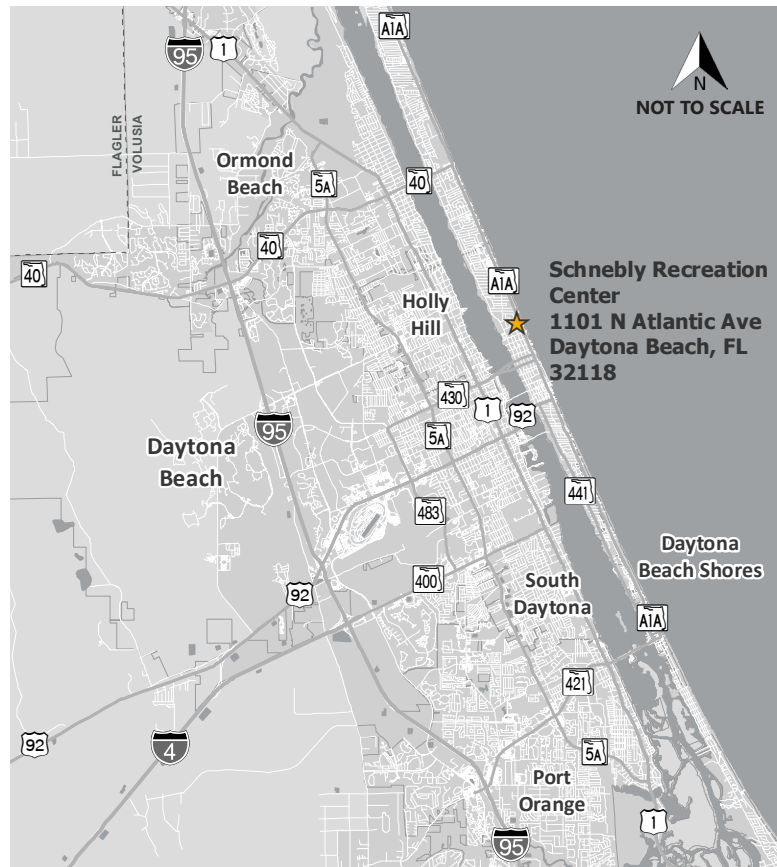
## In-Person Open House Option
