PROJECT DESCRIPTION

The Florida Department of Transportation (FDOT) is making safety and operational improvements to State Road (S.R.) 430 (Mason Avenue) from S.R. 483 (Clyde Morris Boulevard) to just east of Beach Street in Daytona Beach. These improvements include the resurfacing of the roadway to extend its lifespan and key enhancements at four intersections to improve safety and connectivity for pedestrians and motorists.

Planned improvements include the installation of four new midblock pedestrian crossings along the corridor at the intersections of Mason Avenue with Fairmount Road, Edwards Street, Washington Street, and Mulberry Street. Each crossing will also feature a Pedestrian Hybrid Beacon (PHB).

In addition, existing crosswalks throughout the corridor will have upgraded lighting installed to improve visibility and overall safety. A new sidewalk will also be constructed along the north side of Mason Avenue to fill gaps, making it easier, safer, and more convenient for pedestrians to traverse the corridor.

WHAT TO EXPECT

During construction, motorists should expect intermittent overnight lane closures between 8:30 p.m. and 7 a.m. Closures along Mason Avenue will be carried out in segments to minimize impacts on the traveling public. Work will progress from the western end of the corridor heading east throughout the duration of construction.

Electronic message boards and other signage will direct traffic through the work zone. Drivers are urged to use caution, obey all posted signage, and be prepared for potential delays while traveling through the project corridor. The level of work activity and noise will vary during different construction phases. Please note that the construction schedule may change due to inclement weather or other unforeseen circumstances.
