## PROJECT DESCRIPTION

The Florida Department of Transportation (FDOT) is making safety and operational improvements to U.S. 1 (State Road 5) from south of Minnie Lane to the Volusia County Line (County Line Ditch Road). The roadway is being resurfaced throughout the project limits to extend the life of the pavement. Drainage improvements, new guardrail, and roadway signage will be placed as a part of this project. Additionally, new crosswalks, pedestrian signals, and upgraded pedestrian curb ramps will be installed to improve pedestrian safety and meet current Americans with Disabilities Act (ADA) standards.

The existing traffic signal at Anglers Lane/Brockett Road will be enhanced with new Intelligent Transportation Systems (ITS) technology to improve traffic camera operations. Other upgrades include 14 new bus stop pads. Once this project is finished, Space Coast Area Transit will install structures/benches and trash containers at each bus stop.

## WHAT TO EXPECT

During construction, motorists can expect intermittent daytime and nighttime lane closures. Daytime closures will occur between 8 a.m. and 4 p.m. Nighttime closures will occur between 7 p.m. and 6 a.m. Work at the bus stops will occur between 5 p.m. and 8 a.m. This work will be coordinated with the local transit agency to ensure minimal impacts on bus schedules and routes. Flaggers will assist as needed at intersecting roads to maintain traffic flow.

Electronic message boards and other signage will direct traffic through the area. The level of work activity and noise will vary during different construction phases. Please note that the construction schedule is subject to change due to inclement weather or other unforeseen conditions. 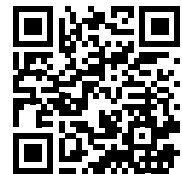
