A1A from Shearwater Parkway to Pineda Causeway (S.R. 404) for FPID No. 447150-1 and from Volunteer Way to Roosevelt Avenue for FPID No. 447150-2 on Tuesday, April 4, 2023, at 5:30 p.m. The purpose of this project is to provide sidewalk connectivity and enhance pedestrian safety.
