The Florida Department of Transportation (FDOT) will hold a public meeting regarding project plans on Silver Star Road (State Road (S.R.) 416) from Princeton Street (S.R. 438) to Orange Blossom Trail (U.S. 441) in Orlando on Thursday, May 25, at 5:30 p.m. The purpose of this project is to repave this segment of Silver Star Road to extend the service life of the existing roadway and to make safety and operational improvements.
