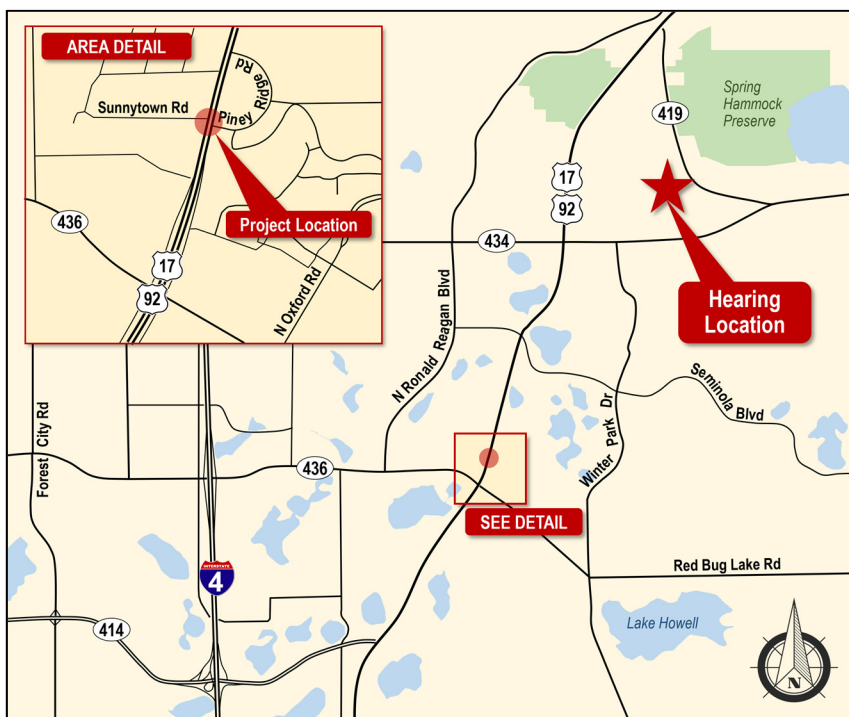

## U.S. 17/92 / State Road (S.R.) 15 at Piney Ridge Road – Roadway Modification

**JOIN US FOR A PUBLIC HEARING ON THURSDAY, MAY 30, 2019**

The Florida Department of Transportation (FDOT) is proposing to improve safety and traffic operations on U.S. 17/92 (S.R. 15) at the intersection with the southern leg of Piney Ridge Road by installing a raised concrete traffic separator between the northbound travel lanes and the crosswalk, as shown below. Based on a qualitative assessment conducted at this location in February 2019, it was recommended that the northbound right turn movement at the intersection be restricted, but traffic exiting the southern leg of Piney Ridge Road onto U.S. 17/92 will still be able to turn right. This modification improves safety in the area by reducing the number of conflict points at this location.

**PROPOSED IMPROVEMENT**



One of the most important responsibilities of the FDOT is to ensure that the design of each state road properly balances access and mobility. Access Management is the planning and control of the location, spacing, design and operation of driveways, median openings and street connections to a roadway. Access Management designates where and how vehicles enter and exit a roadway, helps protect public investment in roadways and improves public safety by preserving mobility, reducing delays and minimizing crashes

A court reporter will be present to record proceedings, and assist with comments, as part of the project record. Written comments can be submitted at the hearing, sent by mail to Dave Mixon, at the address shown to the right, no later than Monday, June 10, 2019. All written and oral comments will become part of the project's public record.
