S.R. A1A from north of Roberta Road to the Flagler County Line

## Volusia County

### PROJECT DESCRIPTION

The Florida Department of Transportation (FDOT) is resurfacing and making safety improvements to State Road (S.R.) A1A from north of Roberta Road to the Flagler County line in northern Volusia County. Improvements include the construction of 18 new crosswalks; three of these will be equipped with Rectangular Rapid Flashing Beacons (RRFBs). RRFBs are pedestrian-activated signals that flash to alert drivers when someone is crossing the roadway.

New signage, pavement markings, and drainage are also included as part of this project. Additional improvements include a 10-foot-wide shared-use path with curb and gutter along the southbound side of S.R. A1A from north of Roberta Road to south of North Peninsula State Park. Two new median islands will also be added at Imperial Heights Drive and Sand Dollar Drive; they will not block access to side streets.

The speed limit will be reduced from 40 and 45 mph to 35 mph from north of Roberta Road to just north of Silk Oaks Drive and remain 35 mph after project completion. The speed limit will be reduced from 45 mph to 40 mph north of Silk Oaks Drive to north of Coquina Key Drive and remain 40 mph after project completion.

The existing posted speed limit of 55 mph from north of Coquina Key Drive to the Flagler County line will be maintained and remain 55 mph after project completion.

### WHAT TO EXPECT

During construction, motorists should expect intermittent northbound and southbound daytime lane closures on S.R. A1A from 7 a.m. to 8 p.m. Construction activities will be limited to only daytime hours for the duration of turtle nesting season. Certain driveways along the project corridor may experience limited access; the affected property owners will be contacted directly.

Uneven pavement is a common, unavoidable roadway condition in resurfacing projects, as the contractor must apply different layers of asphalt during various construction phases. Road conditions during construction are temporary and will improve as the project progresses.

Property owners are responsible for removing or relocating any privately owned irrigation, landscaping, decorations, and fencing within FDOT right of way before construction starts. FDOT reserves the right to cut and cap any irrigation and to remove any items that conflict with the planned work in the right of way. If there are questions about whether you may have items within the right of way, please reach out to the contact above in the orange box.

Drivers are encouraged to follow posted signage, avoid distractions, and travel cautiously while navigating the construction zone. Please note that the construction schedule may change due to inclement weather or other unforeseen circumstances.
