## PROJECT DESCRIPTION

The Florida Department of Transportation (FDOT) is resurfacing a nearly 9-mile stretch of U.S. 17 (State Road (S.R.) 15) from Lake Winona Road to south of East Fourth Avenue in Pierson, extending the roadway's life and enhancing overall safety. In addition to resurfacing, detectable warning devices for individuals with visual impairments will be upgraded at existing sidewalk crossings throughout the project to enhance pedestrian safety and ensure compliance with current Americans with Disabilities Act (ADA) standards. New pavement markings will also be added throughout the project limits.

Approximately 100 feet on either side of the S.R. 40 intersection, is excluded from this project. That portion is being resurfaced separately as part of another project on U.S. 17 and S.R. 40 (FPID No. 451311-1).

## WHAT TO EXPECT

During construction, motorists should expect intermittent lane closures in both directions along U.S. 17. These closures may occur between 6:30 p.m. and 7:30 a.m. and between 8:30 a.m. and 4:30 p.m. Within the project limits, the existing posted speed limit of 60 mph in certain areas will be reduced to 50 mph during construction to improve safety. The existing posted speed limit will be reduced to 45 mph at intersection approaches.

Please be aware that construction activity and noise levels may vary throughout different phases of the project. Motorists should also anticipate areas of uneven pavement within the project limits, a common condition during construction when the contractor applies multiple asphalt layers in phases. Many of these roadway conditions are temporary and will gradually improve as the project progresses.

Electronic message boards and additional signage will help direct traffic through the work zone. Please note that the construction schedule may change due to inclement weather or other unexpected conditions. 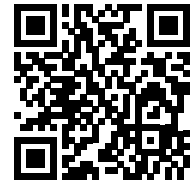
